This Act takes effect December 23 15, 2003, and applies to licenses and fees for bait dealers' 24 activities for years beginning on or after January 1, 2004. 25 EXPLANATION 26 This bill changes the name of the resident and nonresident 27 bait dealer licenses to resident and nonresident retail bait 28 dealer licenses. The bill also creates resident and 29 nonresident wholesale bait dealer licenses. The fee for the 30 resident wholesale bait dealer license is \$200 and the fee for 31 the nonresident wholesale bait dealer license is \$400. Code section 483A.20 is also amended to strike an exception 32 33 to the bait dealers' reciprocity provision which authorized 34 the licensing of nonresident bait dealers who sell at 35 wholesale to licensed dealers in Iowa for resale.
