- 1 Section 1. DEPARTMENT OF EDUCATION. There is appropriated
- 2 from the general fund of the state to the department of
- 3 education for the fiscal year beginning July 1, 2003, and
- 4 ending June 30, 2004, the following amount, or so much thereof
- 5 as is necessary, to be used for the purposes designated:
- 6 For purposes of entering into a competitively bid contract
- 7 with a not-for-profit organization to provide technical
- 8 assistance to school districts and community-based
- 9 organizations that provide mentoring programs to youth:
- 10\$ 350,000
- 11 1. To be eligible for a contract under this section, a
- 12 not-for-profit organization shall apply research-based
- 13 principles and strategies from national prevention programs,
- 14 utilize a variety of media to engage and assist participants,
- 15 and focus on school districts and community-based
- 16 organizations that deliver mentoring programs. Assistance
- 17 shall be designed to focus on program continuation in a low
- 18 funding environment, managing risk, and maximizing outcome-
- 19 based results.
- 20 2. Assistance provided by a not-for-profit organization
- 21 shall demonstrate expertise in the following areas:
- 22 a. Effective program development strategies.
- 23 b. Program-based outcome evaluations for youth served.
- 24 c. Maximizing resources for program continuation.
- 25 d. Development of effective volunteer recruitment and
- 26 appropriate screening techniques.
- e. Development of risk management tools such as program
- 28 supervision and adequate documented procedures for program
- 29 delivery.
- 30 3. Assistance provided by a not-for-profit organization
- 31 shall strive to accomplish the following:
- 32 a. Expand program delivery within the targeted service
- 33 community.
- 34 b. Produce constructive tangible outcomes and results for
- 35 youth served.

- 1 c. Assure program longevity through the use of
- 2 collaboration and volunteer coordination.
- 3 d. Provide for the necessary number of volunteers to
- 4 deliver the program and ensure that each volunteer is safe and
- 5 appropriate.
- 6 4. In determining and approving a not-for-profit
- 7 organization, the department shall place its highest priority
- 8 on the expertise and accomplishments of a not-for-profit
- 9 organization's staff in the area of youth mentoring programs
- 10 related to the areas specified in subsection 2.
- 11 5. The department shall prepare and submit a report of the
- 12 activities and expenditures funded under the contract to the
- 13 chairpersons and ranking members of the standing committees on
- 14 education and to the joint appropriations subcommittees on
- 15 education of the general assembly by December 1, 2005.
- 16 EXPLANATION
- 17 This bill appropriates \$350,000 from the general fund of
- 18 the state to the department of education for fiscal year 2003-
- 19 2004 for the purposes of entering into a competitively bid
- 20 contract with a not-for-profit organization to provide
- 21 technical assistance to school districts and community-based
- 22 organizations that provide mentoring programs to youth.
- Not-for-profit organizations are eliqible for a contract if
- 24 they apply research-based principles and strategies from
- 25 national prevention programs, utilize a variety of media to
- 26 engage and assist participants, and focus on school districts
- 27 and community-based organizations that deliver mentoring
- 28 programs.
- 29 Assistance provided by an eligible organization must be
- 30 designed to focus on program continuation, managing risk, and
- 31 maximizing outcome-based results; must demonstrate expertise
- 32 in effective program development strategies, outcome
- 33 evaluations, maximizing resources, effective volunteer
- 34 recruitment, screening techniques, and risk management tools;
- 35 and must strive to expand program delivery, produce
