- 1 Section 1. <u>NEW SECTION</u>. 152.13 FEES -- SPECIAL FUND 2 CREATED.
- 1. It is the intent of the general assembly that licensing 4 and renewal fees received by the board of nursing shall be 5 used to finance the duties and activities of the board and to 6 provide funding for the administration of the board and all of 7 the board's programs.
- 8 2. Notwithstanding section 147.82, the board of nursing 9 shall collect and retain all licensing and registration fees 10 and shall deposit the fees into the board of nursing special 11 fund, established as a separate fund in the state treasury 12 under the authority of the board for the sole use of the 13 board. Moneys deposited in the special fund shall be 14 considered repayment receipts as defined in section 8.2 and 15 shall be continuously and exclusively available to the board 16 for the purpose of carrying out the duties, activities, and 17 administration of the board, and all of its programs and to 18 pay all costs and expenses incurred in connection with the 19 operation of the board, including but not limited to
- 20 additional full-time equivalent positions and travel. Amount 21 deposited in the special fund shall not be transferred, used, 22 obligated, appropriated, or otherwise encumbered except as 23 provided in this section.
- Notwithstanding section 8.33, moneys deposited in the special fund that remain unencumbered or unobligated at the close of the fiscal year shall not revert to any other fund that shall remain available for expenditure for the purposes designated in future fiscal years. Notwithstanding section 120.7, subsection 2, interest or earnings on moneys deposited into the special fund shall be credited to and remain a part of the special fund.
- 32 3. The executive director of the board shall keep an 33 accurate and detailed account of fees and funds received and 34 deposited, account for any expenditures and refunds made, and 35 manage any fees and funds received to defray board expenses.

- 1 Payments out of the special fund shall be made only upon the
- 2 direction of the board by the executive director of the board.
- 3 The fund shall be subject to annual audit by the auditor of
- 5 Sec. 2. EFFECTIVE DATE. This Act, being deemed of

- 8 This bill provides for the creation of a special fund
- 9 within the state treasury into which shall be deposited
- 10 licensing and registration fees received by the board of
- 11 nursing. The bill provides that a special fund is established
- 12 for the board within the state treasury, and that amounts
- 13 deposited therein shall be used to finance the duties and
- 14 activities of the board and to provide funding for the
- 15 administration of the board and all of its programs. The bill
- 16 provides for the establishment of the fund, notwithstanding a
- 17 provision that directs that licensing fees collected by a
- 18 board shall be deposited into the general fund of the state.
- 19 The bill provides that all licensing and registration fees
- 20 shall be deposited into the fund and shall be considered
- 21 repayment receipts pursuant to Code section 8.2. The bill
- 22 provides that moneys deposited in the fund shall be
- 23 continuously and exclusively available to the board for the
- 24 purpose of carrying out the duties, activities, and
- 25 administration of the board, and all of its programs and to
- 26 pay all costs and expenses incurred in connection with the
- 27 operation of each board, including but not limited to
- 28 additional full-time equivalent positions and travel. The
- 29 bill provides that amounts deposited in the fund shall not be
