AN ACT

RELATING TO THE PURPOSES OF THE COMMUNITY ATTRACTION AND  
TOURISM PROGRAM.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 15F.202, subsection 1, Code 2003, is amended to read as follows:
