- 1 Section 1. Section 135.11, Code 2003, is amended by adding 2 the following new subsection:
- 3 NEW SUBSECTION. 30. Establish a program to collect and
- 4 maintain data on the height, weight, and body mass index of
- 5 students attending participating elementary and secondary
- 6 schools in the state. The department, in consultation with
- 7 the department of education, shall do all of the following:
- 8 a. Recruit schools that are interested in determining and
- 9 tracking the prevalence of overweight students in the schools'
- 10 student population. Except as otherwise provided in this
- 11 paragraph, a participating school must agree to weigh and
- 12 measure all students enrolled in the school to ensure the
- 13 accuracy and validity of the data collected and reported. A
- 14 student shall not be weighed and measured if the student's
- 15 parent or guardian files with the appropriate principal a
- 16 written request that the student be excused from participating
- 17 in the program.
- 18 b. Provide technical assistance to schools to implement
- 19 the program. Technical assistance shall include identifying
- 20 appropriate equipment and techniques to use when weighing and
- 21 measuring students. The weighing and measuring of students
- 22 shall be done under sanitary conditions and with regard for
- 23 the privacy of the student in a location at the school in
- 24 which other persons are not present.
- 25 c. Develop a system of numerical and alpha identifiers to
- 26 allow for reporting data by school, school district, and

- 34 This bill directs the Iowa department of public health to

Description

House File 418 directs the Department of Public Health to establish a program for the collection and maintenance of data on height, weight, and body mass index of elementary and secondary students at schools that voluntarily participate in the Program. A student will be excused from participation in the Program if the student's parent files a written request with the principal. The Bill also directs the Department of Public Health to provide technical assistance to participating schools, to develop numerical and alpha identifiers, and to enter the data received into the federal Centers for Disease Control and Prevention's Pediatric Nutrition Surveillance System.

Assumptions

- 1. Thirty school districts will volunteer to participate and will collect height and weight data for a total of 125,000 students.
- 2. School nurses will notify parents of the Program and collect and submit data to the Department of Public Health.
- 3. The average time school nurses will spend collecting and preparing data to submit to the Department will be 16 hours per district for a total of 480 hours at a cost of \$24 per hour.
- 4. Of the data submitted, the Department of Public Health will use a sample of 28,750 (23.0%) students to include all 3rd, 5th, and 9th graders and will compile, analyze, and enter the data for this sample into the federal Pediatric Nutrition Surveillance System.
- 5. The Department will spend 480 hours at a cost of \$17 per hour on data entry related to the Program. In addition, the Department will have indirect administrative costs totaling an estimated \$3,000 per year.

Fiscal Impact

The fiscal impact of HF 418 is expected to be minimal. The annual cost to the Department of Public Health will be an estimated \$11,000. The annual cost to local school districts that volunteer to participate in the Program will be less than \$500 per district.
