      This bill amends Code section 554.3512 in Article 3 of the
9 Uniform Commercial Code regulating negotiable instruments
10 (providing a promise to pay an amount of money payable to the
11 bearer upon demand or at some definite time).
12 increases the surcharge that may be assessed against checks,
13 drafts, or orders which are dishonored from $20 to $30.
      The bill eliminates a provision that the amount of the
14
15 surcharge could also equal 5 percent of the face value of the
16 instrument, which could be above the $20 surcharge amount in
17 current law. Finally, the bill eliminates a provision that if
18 the financial instrument was presented twice or the maker does
19 not have an account with the drawee, the amount of the
20 surcharge could increase to $50.

6 dollars or five percent of the face value of the check.
7 However, the amount of the surcharge shall not exceed twenty
8 thirty dollars unless the check, draft, or order was presented
9 twice or the maker does not have an account with the drawee.
10 If the check, draft, or order was presented twice or the maker
11 does not have an account with the drawee, the amount of the
12 surcharge shall not exceed fifty dollars.
