- 1 Section 1. Section 217.3, Code 2003, is amended by adding 2 the following new subsection:
- 3 NEW SUBSECTION. 9. Adopt and phase in the implementation
- 4 of caseload standards so that the caseloads of social workers
- 5 who are employed by or contract with the department do not
- 6 exceed applicable caseload standards adopted by or recommended
- 7 by a recognized national accrediting body or professional
- 8 organization, including but not limited to the national
- 9 association of social workers, the council on accreditation,
- 10 and the child welfare league of America. The standards shall
- 11 be fully implemented on or before July 1, 2010.
- 12 Sec. 2. SOCIAL WORKER CASELOAD STANDARDS IMPLEMENTATION
- 13 PLAN. The department of human services shall develop a plan
- 14 for approval by the council on human services for phased-in
- 15 implementation of the social worker caseload standards
- 16 required by section 217.3, subsection 9, as enacted by this
- 17 Act. The first phase of the plan shall be incorporated in the
- 18 department and council's budget recommendations for the fiscal
- 19 year beginning July 1, 2005. The plan shall be submitted to
- 20 the governor and general assembly on or before December 15,
- 21 2004.
- 22 EXPLANATION
- 23 This bill requires the department of human services to
- 24 adopt social worker caseload standards. The Code section
- 25 217.3 duties of the council on human services are amended to
- 26 direct the council to adopt and phase in caseload standards
- 27 with full implementation on or before July 1, 2010. The
- 28 caseload standards are required to conform to the applicable
- 29 standards adopted by or recommended by a national accrediting
- 30 body or professional organization, including the national
- 31 association of social workers, the council on accreditation,
- 32 and the child welfare league of America. The department is
- 33 directed to develop an implementation plan for approval by the
- 34 council and the budgets recommended by the department and
- 35 council for fiscal year 2005-2006 are required to incorporate
