A BILL FOR

1 An Act authorizing the issuance of special registration plates to
2 owners of motor trucks.

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321.34, subsection 3, Code 2003, is 2 amended to read as follows:
- 3. RADIO OPERATORS PLATES. The owner of an automobile,
- 4 light-delivery-truck, -panel-delivery-truck, motorcycle,
- 5 trailer, or pickup motor truck who holds an amateur radio
- 6 license issued by the federal communications commission may,
- 7 upon written application to the county treasurer accompanied
- 8 by a fee of five dollars, order special registration plates
- 9 bearing the call letters authorized the radio station covered
- 10 by the person's amateur radio license. When received by the
- 11 county treasurer, such special registration plates shall be
- 12 issued to the applicant in exchange for the registration
- 13 plates previously issued to the person. Not more than one set
- 14 of special registration plates may be issued to an applicant.
- 15 Said fee shall be in addition to and not in lieu of the fee
- 16 for regular registration plates. Special registration plates
- 17 must be surrendered upon expiration of the owner's amateur
- 18 radio license and the owner shall thereupon be entitled to the
- 19 owner's regular registration plates. The county treasurer
- 20 shall validate special plates in the same manner as regular
- 21 registration plates, upon payment of five dollars in addition
- 22 to the regular annual registration fee.
- Sec. 2. Section 321.34, subsection 8, unnumbered paragraph
- 24 1, Code 2003, is amended to read as follows:
- 25 The owner of a motor vehicle subject to registration under
- 26 section 321.109, subsection 1, light-delivery-truck; -panel
- 27 delivery-truck, motorcycle, trailer, or pickup motor truck who
- 28 has been awarded the congressional medal of honor may, upon
- 29 written application to the department, order special
- 30 registration plates which shall be red, white, and blue in
- 31 color and shall bear an emblem of the congressional medal of
- 32 honor and an identifying number. Each applicant applying for
- 33 special registration plates under this subsection may purchase
- 34 only one set of registration plates under this subsection.
- 35 The application is subject to approval by the department and

- 1 the special registration plates shall be issued to the
- 2 applicant in exchange for the registration plates previously
- 3 issued to the person. The special plates are subject to an
- 4 annual registration fee of fifteen dollars. The department
- 5 shall validate the special plates in the same manner as
- 6 regular registration plates are validated under this section.
- 7 The department shall not issue special registration plates
- 8 until service organizations in the state have furnished the
- 9 department either the special dies or the cost of the special
- 10 dies necessary for the manufacture of the special registration
- 11 plate.

7 10. FIRE FIGHTER PLATES. The owner of a motor vehicle 2 subject to registration pursuant to section 321.109, 3 subsection 1, light-delivery-truck,-panel-delivery-truck, 4 pickup, motor truck, motor home, multipurpose vehicle, 5 motorcycle, trailer, or travel trailer who is a current or 6 former member of a paid or volunteer fire department, may upon 7 written application to the department, order special 8 registration plates, designed by the department in cooperation 9 with representatives designated by the Iowa fire fighters' 10 associations, which plates signify that the applicant is a 11 current or former member of a paid or volunteer fire 12 department. The application shall be approved by the 13 department, in consultation with representatives designated by 14 the Iowa fire fighters' associations, and the special 15 registration plates shall be issued to the applicant in 16 exchange for the registration plates previously issued to the The fee for the special plates shall be twenty-five 18 dollars which shall be in addition to the regular annual 19 registration fee. The department shall validate the special 20 plates in the same manner as regular registration plates are 21 validated under this section at the regular annual 22 registration fee. 23 EMERGENCY MEDICAL SERVICES PLATES. The owner of a 24 motor vehicle subject to registration pursuant to section 25 321.109, subsection 1, light-delivery-truck,-panel-delivery 26 truck, -pickup, motor truck, motor home, multipurpose vehicle, 27 motorcycle, trailer, or travel trailer who is a current member 28 of a paid or volunteer emergency medical services agency may, 29 upon written application to the department, order special 30 registration plates, designed by the department in cooperation 31 with representatives designated by the Iowa emergency medical 32 services association, which plates signify that the applicant 33 is a current member of a paid or volunteer emergency medical 34 services agency. The application shall be approved by the

35 department, in consultation with representatives designated by

- 1 the Iowa emergency medical services association, and the
- 2 special registration plates shall be issued to the applicant
- 3 in exchange for the registration plates previously issued to
- 4 the person. The fee for the special plates shall be twenty-
- 5 five dollars which shall be in addition to the regular annual
- 6 registration fee. The department shall validate the special
- 7 plates in the same manner as regular registration plates are
- 8 validated under this section at the regular annual
- 9 registration fee.

Under current law, the only truck owners eligible for 2 special motor vehicle registration plates issued by the state 3 department of transportation are owners of light delivery 4 trucks, panel delivery trucks, and pickups. This bill amends 5 Code section 321.34 to allow the owner of any motor truck to 6 order special registration plates.
