Section 1. Section 321.182, Code 2003, is amended by 2 adding the following new subsection: NEW SUBSECTION. 5. Upon application for a driver's 4 license or renewal of a driver's license, provide evidence 5 that the applicant is covered as a driver under a motor 6 vehicle owner's policy of liability insurance or other form of 7 financial liability coverage required for operation of a motor 8 vehicle under section 321.20B. For the purposes of this 9 subsection, "evidence" means a valid liability insurance 10 policy number or other information as determined by the 11 department by rule. A licensee shall notify the department 12 when the licensee's liability insurance policy number or form 13 of financial liability coverage changes and provide the new 14 evidence of financial liability coverage within thirty days of 15 the change. 16 EXPLANATION 17 This bill requires an applicant for a driver's license or 18 for renewal of a driver's license to provide evidence that the 19 applicant has financial liability coverage as a driver of a 20 motor vehicle. The licensee must provide new evidence of 21 financial liability coverage within 30 days of a change in the 22 licensee's liability insurance policy number or form of 23 financial liability coverage. The state department of 24 transportation is required to establish by rule the types of 25 evidence, in addition to a valid liability insurance policy 26 number, which would satisfy the requirement. 27 28 29 30 31 32 33 34
