Section 1. Section 97A.6, subsection 5, paragraph b, Code
 2 2003, is amended to read as follows:
     b. Should a member in service become incapacitated for
 4 duty as a natural and proximate result of an injury, disease,
 5 or exposure incurred or aggravated while in the actual
6 performance of duty at some definite time or place, the member
 7 shall, upon being found to be temporarily incapacitated
8 following an examination by the board of trustees, be entitled
9 to receive the member's fixed pay and allowances, without
10 using the member's sick leave, until re-examined reexamined by
11 the board and found to be fully recovered or permanently
12 disabled. In addition, a member found to be temporarily
13 incapacitated under this paragraph shall be credited with any
