- 1 Section 1. <u>NEW SECTION</u>. 29A.27A LIFE INSURANCE PREMIUM 2 REIMBURSEMENTS.
- 3 1. Subject to an appropriation of sufficient funds by the
- 4 general assembly, a member of the national guard on active
- 5 duty in the military service of this state or of the United
- 6 States is eligible for reimbursement for premiums paid for a
- 7 life insurance policy with limits up to and including two

- 28 for a life insurance policy with limits up to and including
- 29 \$250,000 that is obtained through the federal servicemembers'
- 30 group life insurance program, subject to an appropriation of
- 31 sufficient funds by the general assembly. The bill also
- 32 provides that the adjutant general shall adopt rules necessary
- 33 to determine eligibility for the reimbursement payments and to
- 34 administer a reimbursement program.
