- 1 Section 1. Section 15G.111, subsection 3, Code Supplement
- 2 2005, is amended by striking the subsection.
- 3 Sec. 2. Section 303.3C, Code Supplement 2005, is amended
- 4 by adding the following new subsection:
- 5 NEW SUBSECTION. 4. For the fiscal period beginning July
- 6 1, 2006, and ending June 30, 2015, there is appropriated each
- 7 fiscal year from the grow Iowa values fund created in section
- 8 15G.108 to the department of cultural affairs one million
- 9 dollars for purposes of providing financial assistance for
- 10 projects in targeted state parks, banner parks, and
- 11 destination parks. The department of natural resources shall
- 12 submit a plan to the department of cultural affairs for the
- 13 expenditure of moneys appropriated under this subsection. The
- 14 plan shall focus on improving state parks, banner parks, and
- 15 destination parks for economic development purposes. Based on
- 16 the plan submitted, the department of cultural affairs shall
- 17 provide financial assistance to the department of natural
- 18 resources for support of state parks, banner parks, and
- 19 destination parks. For purposes of this subsection, "banner
- 20 park" means a park with multiple uses and which focuses on the
- 21 economic development benefits of a community or area of the
- 22 state.
- 23 EXPLANATION
- 24 This bill relates to financial assistance for projects in
- 25 targeted state parks, banner parks, and destination parks and
- 26 makes appropriations.
- 27 For the fiscal period beginning July 1, 2006, and ending
- 28 June 30, 2015, the bill appropriates each fiscal year from the
- 29 grow Iowa values fund to the department of cultural affairs \$1
- 30 million for purposes of providing financial assistance for
- 31 projects in targeted state parks, banner parks, and
- 32 destination parks. The bill requires the department of
- 33 natural resources to submit a plan to the department of
- 34 cultural affairs for the expenditure of moneys appropriated in
- 35 the bill. The bill provides that the plan must focus on

```
1 improving state parks, banner parks, and destination parks for
 2 economic development purposes. The bill provides that, based
 3 on the plan submitted, the department of cultural affairs
 4 shall provide financial assistance to the department of
 5 natural resources for support of state parks, banner parks,
 6 and destination parks.

      The bill eliminates a similar appropriation to the
 8 department of economic development.
