- 1 Section 1. Section 331.341, subsection 1, Code 2005, is 2 amended to read as follows:
- 3 1. When the estimated cost of a public improvement, other
- 4 than improvements which may be paid for from the secondary
- 5 road fund, exceeds the amount specified in section 309.40 or,
- 6 for a county hospital exceeds one hundred thousand dollars,
- 7 the board shall follow the contract letting procedures
- 8 provided for cities in sections 384.95 to 384.103. However,
- 9 in following those sections the board shall substitute the
- 10 word "county" for the word "city", section 331.305 for section
- 11 362.3, shall consider "governing body" to mean the board, and
- 12 shall exclude references to a city utility, utility board of
- 13 trustees, or public utilities. As used in this section,
- 14 "public improvement" means the same as defined in section
- 15 384.95 as modified by this subsection. This subsection
- 16 applies to all county hospitals whether organized under
- 17 chapter 37, 347, or 347A, or otherwise established by law.
- 18 Sec. 2. Section 384.96, Code 2005, is amended to read as
- 19 follows:
- 20 384.96 SEALED BIDS.
- 21 When the estimated total cost to a city of a public
- 22 improvement exceeds the sum of twenty-five thousand dollars
- 23 or, for a city hospital, including a city memorial hospital,
- 24 exceeds the sum of one hundred thousand dollars, the governing
- 25 body shall advertise for sealed bids for the proposed
- 26 improvement by publishing a notice to bidders as provided in
- 27 section 362.3, except that the notice to bidders may be
- 28 published more than twenty days but not more than forty-five
- 29 days before the date for filing bids.
- 30 EXPLANATION
- 31 This bill raises the bid threshold amount for county and
- 32 city hospital public improvements. For county hospitals,
- 33 whether organized pursuant to Code chapter 37, 347, or 347A,
- 34 or otherwise established by law, the bid threshold amount is
- 35 raised from \$50,000 to \$100,000. Similarly, for city

1 hospitals, including city memorial hospitals, the bid
 2 threshold is raised from $25,000 to $100,000.
