1 Section 1. Section 8.54, subsection 2, Code 2005, is 2 amended to read as follows:

3 2. There is created a state general fund expenditure 4 limitation for each fiscal year calculated as provided in this 5 section. An expenditure limitation shall be used for the 6 portion-of the budget process commencing on the date the 7 revenue estimating conference agrees to a revenue estimate for 8 the following fiscal year in accordance with section 8.22A, 9 subsection 3, and ending with the governor's-final-approval-or 10 disapproval-of-the-appropriations-bills-applicable-to-that 11 fiscal-year-that-were-passed-prior-to-July-1-of-that-fiscal 12 year-in-a-regular-or-extraordinary-legislative-session close 13 of that following fiscal year. Once that following fiscal 14 year commences, the expenditure limitation for that fiscal 15 year is not subject to adjustment or readjustment except by 16 law enacted for that purpose.

17 Sec. 2. EFFECTIVE AND APPLICABILITY DATES. This Act takes 18 effect July 1, 2006, and is first applicable to the state 19 general fund expenditure limitation established for the fiscal 20 year beginning July 1, 2007.

EXPLANATION

This bill relates to the state general fund expenditure 22 23 limitation by extending the duration of the limitation. 24 The bill amends Code section 8.54 to require the 25 expenditure limitation to be used for the budget process until 26 the close of the fiscal year to which the expenditure 27 limitation applies. Current law provides the expenditure 28 limitation is applicable for the budget process until the 29 governor's final approval or disapproval of the appropriations 30 bills that were passed prior to July 1 of the fiscal year to 31 which the limitation applies. Under the bill, once the fiscal 32 year for which the expenditure limitation was calculated 33 commences, the expenditure limitation for that fiscal year is 34 not subject to adjustment or readjustment except by law 35 enacted for that purpose.

The bill takes effect July 1, 2006, and is first applicable 2 to the state general fund expenditure limitation established 3 for the fiscal year beginning July 1, 2007. LSB 5666HH 81
