- 2 LIMITATIONS ON AMOUNTS IN LEGISLATIVE ELECTIONS.
- 3 l. The aggregate amount of contributions made to a
- 4 candidate for the senate or the house of representatives and
- 5 the candidate's committee by a committee or a person other
- 6 than the candidate shall not exceed a total of one thousand
- 7 dollars in cash and one thousand dollars in in-kind
- 8 contributions for each primary election, or in lieu thereof a
- 9 convention of a political party, and an equal amount for each
- 10 general election.

- 28 primary election, or in lieu thereof a convention of a
- 29 political party, and an equal amount for each general
- 30 election.
- 31 The bill also limits contributions made by a political
- 32 party to a candidate for the senate or house of
- 33 representatives, to a total of \$2,500 in cash and \$2,500 in
- 34 in-kind contributions for each primary election, or in lieu
- 35 thereof a convention of a political party, and an equal amount
