- 1 Section 1. Section 321.34, Code 2005, is amended by adding 2 the following new subsection:
- 3 NEW SUBSECTION. 24. COLORECTAL CANCER AWARENESS PLATES.
- 4 a. Upon application and payment of the proper fees, the
- 5 director may issue colorectal cancer awareness plates to an
- 6 owner of a type of motor vehicle referred to in subsection 12.
- 7 b. Colorectal cancer awareness plates shall bear an emblem
- 8 containing the colorectal cancer blue star symbol, to be
- 9 designed by the department in consultation with voices of
- 10 Iowa, the Iowa affiliate of the colon cancer alliance.
- 11 c. The special fee for letter number designated colorectal
- 12 cancer awareness plates is thirty-five dollars. The fee for
- 13 personalized colorectal cancer awareness plates is twenty-five
- 14 dollars, which shall be paid in addition to the special
- 15 colorectal cancer awareness fee of thirty-five dollars. The
- 16 fees collected by the director under this subsection shall be
- 17 paid monthly to the treasurer of state and credited to the
- 18 road use tax fund. Notwithstanding section 423.43, and prior
- 19 to the crediting of revenues to the road use tax fund under
- 20 section 423.43, subsection 1, paragraph "b", the treasurer of
- 21 state shall transfer monthly from those revenues to the Iowa
- 22 department of public health the amount of the special fees
- 23 collected in the previous month for the colorectal cancer
- 24 awareness plates and such funds are appropriated to the Iowa
- 25 department of public health to be used for projects that
- 26 promote colorectal cancer awareness and screenings.
- 27 Notwithstanding section 8.33, moneys transferred under this
- 28 subsection shall not revert to the general fund of the state.
- 29 d. Upon receipt of the special registration plates, the
- 30 applicant shall surrender the current registration plates to
- 31 the county treasurer. The county treasurer shall validate the
- 32 special registration plates in the same manner as regular
- 33 registration plates are validated under this section. The
- 34 annual special colorectal cancer awareness fee for letter
- 35 number designated plates is ten dollars, which shall be paid

1 in addition to the regular annual registration fee. 2 annual fee for personalized colorectal cancer awareness plates 3 is five dollars, which shall be paid in addition to the annual 4 special colorectal cancer awareness fee and the regular annual 5 registration fee. The annual special colorectal cancer 6 awareness fee shall be credited and transferred as provided 7 under paragraph "c". EXPLANATION This bill creates a special colorectal cancer awareness 10 motor vehicle registration plate bearing an emblem with the 11 colorectal cancer blue star symbol, to be designed by the 12 state department of transportation in consultation with voices 13 of Iowa, an affiliate of the colon cancer alliance. 14 will be issued for a special fee of \$35, plus an additional 15 \$25 for a personalized plate. The annual special renewal fee, 16 which is in addition to the regular annual registration fee 17 for the vehicle, is \$10, plus an additional \$5 for 18 personalized plates. Moneys from the \$35 special plate 19 issuance fee and the \$10 special plate renewal fee are 20 appropriated to the Iowa department of public health to be 21 used to promote colorectal cancer awareness and screenings. 22 23 24 25 26 27 28 29 30 31 32 33 34
