- 23 1. At least twice during each school year, the board of
- 24 directors of each school district operating a high school and
- 25 the authorities in charge of each accredited nonpublic school
- 26 shall offer the opportunity to register to vote to each
- 27 student who is at least seventeen and-one-half years of age.

- 11 whose deaths have been reported to the bureau of vital records
- 12 of the Iowa department of public health since the previous
- 13 list of decedents was certified to the state registrar of
- 14 voters. The list shall be submitted according to the
- 15 specifications of the state registrar of voters, who shall
- 16 determine whether each listed decedent was registered to vote
