1 Section 1. Section 321.34, Code Supplement 2005, is
2 amended by adding the following new subsection:

3 NEW SUBSECTION. 24. GOLD STAR PLATES. An owner referred
4 to in subsection 12 who is the surviving spouse or surviving
5 parent of a deceased member of the United States armed forces
6 who died during a time of military conflict may order special
7 registration plates bearing a gold star emblem upon written
8 application to the department accompanied by satisfactory
9 supporting documentation as determined by the department. The
10 gold star emblem shall be designed by the department in
11 cooperation with the commission of veterans affairs. Letter
12 number designated gold star plates shall be issued at no
13 charge and shall be validated annually by the county treasurer
14 upon payment of the regular annual registration fee. The fee
15 for issuance of personalized gold star plates is twenty-five
16 dollars, and the annual fee for personalized gold star plates
17 is five dollars, which is in addition to the regular annual
18 registration fee.

19 EXPLANATION

20 This bill establishes a new special motor vehicle
21 registration plate to be issued free of charge to a surviving
22 spouse or surviving parent of a deceased member of the United
23 States armed forces who died during a time of military
24 conflict. The special gold star registration plates shall be
25 issued at no charge to the applicant and renewed upon payment
26 of the annual registration fees for the vehicle. Personalized
27 gold star plates shall be issued for a fee of \$25 and renewed
28 upon payment of the annual registration fees for the vehicle
29 plus a \$5 personalized plate renewal fee.
