EXPLANATION

This bill allows certain associations to qualify as 2 28 self=insurers for purposes of Iowa's motor vehicle financial 2 29 responsibility laws.

Code section 321.20B is amended to provide that an 2 31 association of individual members that is issued a certificate 2 32 of self=insurance pursuant to Code section 321A.34, subsection 33 2, is required to maintain in each vehicle of an individual 34 member a financial liability card that complies with the 35 provisions of the section and in addition contains information 1 relating to the association and the association's certificate 2 of self=insurance as deemed appropriate by the commissioner of 3 insurance or the director of the department of transportation.

Code section 321.34 is amended by adding a new subsection 5 that allows an association of individual members that is a 6 legal entity with the power to sue and be sued in its own name 7 and which is composed of individual members in whose names a 8 total of more than 25 motor vehicles are registered, to 9 qualify as a self=insurer by obtaining a certificate of 3 10 self=insurance issued by the department of transportation.

3 11 The bill further provides that the department shall issue 12 such a certificate of self=insurance if the department is 3 13 satisfied that the association has and will continue to have 3 14 the ability to pay judgments obtained against the association 3 15 or against an individual member of the association for damages 3 16 arising out of the ownership, maintenance, or use of any 3 17 vehicle owned by an individual member of the association. 3 18 association that is issued a certificate of self=insurance is 19 required to maintain a financial liability coverage card as 3 20 described above.
