Section 15E.175, subsection 1, Code 2007, is 1 2 amended by striking the subsection and inserting in lieu 3 thereof the following: 1. The department shall establish a physical infrastructure financial assistance program to provide 6 financial assistance for business or community physical 7 infrastructure development or redevelopment projects. 8 Physical infrastructure development or redevelopment projects 9 include but are not limited to infrastructure projects 1 10 involving any mode of transportation; public works and 1 11 utilities such as sewer, water, power, or telecommunications; 1 12 physical improvements which mitigate, prevent, or eliminate 1 13 environmental contaminants; and any other project deemed 1 14 appropriate by the department.
1 15 a. Physical infrastructure projects that create the 1 16 necessary infrastructure for economic success throughout Iowa, 1 17 that provide the foundation for the creation of quality, 1 18 high-wage jobs, and that involve substantial capital 1 19 investment may be eligible for financial assistance under the 1 20 program if within three years of the completion of the 21 project, the project meets certain performance measurements 1 22 established by the department. If, at the end of the 1 23 three=year period, the project has not met the performance 1 24 measurements established by the department, the department may 1 25 seek to reclaim any funds granted through the program. At the 1 26 department's discretion, a project may be granted an 1 27 additional year of time to meet the performance measurements 1 28 of this subsection. b. The department shall adopt rules governing the awarding 1 30 and use of funds pursuant to this section. 1 31 Sec. 2. Section 15G.111, subsection 1, paragraph a, Code 1 32 Supplement 2007, is amended to read as follows: a. For the fiscal period beginning July 1, 2005 2007, and 1 33 1 34 ending June 30, 2015, there is appropriated each fiscal year 1 35 from the grow Iowa values fund created in section 15G.108, the 1 following amounts for the purposes designated: (1) For the fiscal year beginning July 1, 2005, and ending 3 June 30, 2006, to the department of economic development 2 4 thirty=five million dollars for programs administered by the 5 department of economic development. 2 6 (2) For each fiscal year of the fiscal period beginning 2 7 July 1, 2006, and ending June 30, 2007, to the department of 2 8 economic development thirty=three million dollars for programs 2 9 administered by the department of economic development. 2 10 (3) (1) For each fiscal year of the fiscal period 2 11 beginning July 1, 2007, and ending June 30, 2009, to the 2 12 department of economic development thirty million dollars for 2 13 the following programs administered by the department of 2 14 economic development.:

(4) (2) For each fiscal year of the fiscal period 2 28 2 29 beginning July 1, 2009, and ending June 30, 2015, to the 2 30 department of economic development thirty=two million dollars 2 31 for the following programs administered by the department of economic development.:

(a) The targeted small business financial a program established pursuant to section 15.247. <u>assistance</u>

(b) The community economic betterment program established 2 35 pursuant to section 15.317.

The entrepreneurial venture assistance program (c) established pursuant to section 15.339.

3 4 (d) The value=added agricultural products and processes financial assistance program established pursuant to section 15E.111.

(e) The physical infrastructure financial assistance 8 program established pursuant to section 15E.175.

9 (f) The loan and credit guarantee program established 10 pursuant to section 15E.224.

Sec. 3. Section 15G.111, Code 2007, is amended by adding 3 12 the following new subsection:

NEW SUBSECTION. 8A. For the fiscal period beginning July 3 13 3 14 1, 2009, and ending June 30, 2015, from the moneys 3 15 appropriated each fiscal year from the grow Iowa values fund 3 16 created in section 15G.108, to the department for program 3 17 administration pursuant to subsection 1, paragraph "a", the 3 18 department may allocate up to five million dollars to projects 3 19 qualifying for assistance under the physical infrastructure 3 20 financial assistance program established pursuant to section 21 15E.175 which, notwithstanding section 15G.112, shall not be 22 subject to job or wage requirements. The department may 23 allocate moneys from the grow Iowa values fund above five 3 24 million dollars each year to projects qualifying for 25 assistance under the physical infrastructure financial 26 assistance program but such projects shall be subject to the 3 27 job and wage requirements of section 15G.112.

Sec. 4. Section 15G.112, subsections 1 and 3, Code 2007, 29 are amended to read as follows:

1. In order to <u>be eligible to</u> receive financial assistance 3 31 from the department from the moneys appropriated in section 32 15G.111, subsection 1, paragraph "a", from the grow Iowa
33 values fund to the department for programs administered by the 34 department, the average annual wage, including benefits, of 3 35 new jobs created must be equal to or greater than one hundred thirty percent of the average county wage. For purposes of 2 this section, "average county wage" and "benefits" mean the 3 same as defined in section 15I.1.

3. In awarding moneys appropriated to the department pursuant to section 15G.111, subsection 1, paragraph "a" 6 the grow Iowa values fund for programs administered by the 7 department, the department shall give special consideration to 8 projects that include significant physical infrastructure 4 9 components designed to increase property tax revenues to local 4 10 governments.

Sec. 5. EFFECTIVE DATE. This Act, being deemed of 4 12 immediate importance, takes effect upon enactment. EXPLANATION

This bill relates to moneys appropriated from the grow Iowa 4 15 values fund.

Currently, \$50 million is appropriated each year to the 4 17 grow Iowa values fund, and of those moneys, \$30 million is 4 18 appropriated to the department of economic development to fund 4 19 certain programs. Programs funded in this way are subject to 4 20 job and wage creation requirements.

The bill allows the department to allocate at least \$5 22 million to the physical infrastructure assistance program and 4 23 exempts projects funded by this program from the job and wage 24 requirements as long as the project is an infrastructure 25 project that meets certain performance measurements set by the 4 26 department of economic development.

Finally, the bill makes certain conforming amendments to

- 4 28 the grow Iowa values fund and the physical infrastructure 4 29 assistance program to specify program requirements. 4 30 The bill takes effect upon enactment. 4 31 LSB 5878SV 82 4 32 tw/rj/24
