      Section 1. Section 423.2, subsection 6, Code 2009, is

      6. a. The sales price of any of the following enumerated

Refunds of taxes, interest, or penalties 25 which arise from claims resulting from the amendment of section 26 423.2, subsection 6, in this Act, for the exemption of sales 27 of executive search agencies and private employment agencies 28 occurring between January 1, 2002, and the effective date of 29 this Act, shall be limited to fifty thousand dollars in the 30 aggregate and shall not be allowed unless refund claims are 31 filed prior to October 1, 2010, notwithstanding any other 32 provision of law. If the amount of claims totals more than 33 fifty thousand dollars in the aggregate, the department of 34 revenue shall prorate the fifty thousand dollars among all 35 claimants in relation to the amounts of the claimants' valid

- 1 claims. Claimants shall not be entitled to interest on any
- 2 refunds.
- 3 Sec. 3. EFFECTIVE UPON ENACTMENT AND RETROACTIVE
- 4 APPLICABILITY. This Act, being deemed of immediate importance,
- 5 takes effect upon enactment and applies retroactively to
- 6 January 1, 2002.
- 7 EXPLANATION
- 8 This bill relates to the imposition of the sales tax on
- 9 certain enumerated services.
- 10 Currently, the sales tax is imposed on the services provided
- 11 by executive search agencies and private employment agencies.
- 12 The bill exempts such agencies' services from the list of
- 13 enumerated services upon which the sales tax is imposed.
- Because the exemptions are retroactive to January 1, 2002,
- 15 the bill provides for refunds of taxes, interest, or penalties
- 16 which arise from claims resulting from the change to exemption
- 17 from taxation of these services. These refunds are limited to
- 18 \$50,000 in the aggregate. Claims for refund must be filed by
- 19 October 1, 2010.
- 20 The bill takes effect upon enactment and applies
- 21 retroactively to January 1, 2002.
