A BILL FOR

- 1 An Act relating to the disposition of certain former school
- 2 district funds by the director of the department of
- 3 education and including effective date, validation, and
- 4 retroactive applicability provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. DEPARTMENT OF EDUCATION AUTHORIZING FUND
- 2 TRANSFERS VALIDATION AND RETROACTIVE APPLICABILITY.
- 3 l. a. Notwithstanding any other statute or rule of law
- 4 to the contrary, if a school district whose accreditation was
- 5 removed by action of the state board of education effective
- 6 July 1, 2008, had a negative fund balance in its general fund
- 7 at the end of the school budget year beginning July 1, 2007,
- 8 the director of the department of education is authorized
- 9 to and shall approve by August 1, 2010, the transfer of any
- 10 positive balance from one or more funds of the school district
- 11 to the school district's general fund for the school budget
- 12 year beginning July 1, 2007, and the transfer made is hereby
- 13 validated and to that extent, this Act applies retroactively to
- 14 July 1, 2007.
- b. On the date on which the director of the department
- 16 of education approves the transfer of funds pursuant to this
- 17 subsection, the department shall provide notice of the approval
- 18 of the funds transferred pursuant to this subsection to the
- 19 boards of directors of the school districts to which the former
- 20 school district's territory was merged and shall transmit to
- 21 the state board of education a record of the approval of the
- 22 funds transferred pursuant to this subsection.
- 23 2. The board of directors of a school district to which the
- 24 former school district's territory was merged shall be exempted
- 25 from any liability resulting from the action taken by the
- 26 director of the department of education pursuant to subsection
- 27 l if the school board, within 30 days of the date on which the
- 28 director of the department of education took action pursuant to
- 29 subsection 1, adopts a resolution to accept the action taken by
- 30 the director pursuant to subsection 1.
- 31 Sec. 2. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
- 32 immediate importance, takes effect upon enactment.
- 33 EXPLANATION
- 34 This bill provides that if a school district whose
- 35 accreditation was removed by action of the state board of

- 1 education effective July 1, 2008, had a negative fund balance
- 2 in its general fund at the time its accreditation was removed,
- 3 the director of the department of education is authorized
- 4 to and shall by August 1, 2010, approve the transfer of any
- 5 positive balance from one or more funds of the school district
- 6 to the school district's general fund. The board of directors
- 7 of a school district to which the former school district's
- 8 territory was merged is exempt from any liability resulting
- 9 from the transfer if the school board, within 30 days of the
- 10 date the director takes action to transfer the funds, adopts a
- 11 resolution to accept the action taken by the director.
- 12 On the date on which the director approves the transfer of
- 13 funds, the department must provide notice of the director's
- 14 approval of the funds transfer to the affected school boards
- 15 and shall transmit to the state board of education a record of
- 16 the director's approval of the funds transfer.
- 17 The bill takes effect upon enactment.
