Section 1. REESTABLISHMENT OF A TECHNICAL ADVISORY 1 2 COMMITTEE REEVALUATION OF THE MASTER MATRIX. A technical advisory committee is created to reevaluate 3 4 the master matrix as provided in section 359.305 and 567 IAC 5 chapter 65, appendix C. 6 The committee shall be composed of all of the following: 1. 7 a. A designee of the secretary of agriculture. 8 b. A designee of the director of the department of natural 9 resources. 10 c. A designee of the president of the university of Iowa. d. A designee of the president of Iowa state university. 11 12 e. A representative of the Iowa environmental council. 13 f. A representative of the Iowa state association of 14 counties. g. A representative of the Iowa farm bureau federation. 15 16 h. A representative of the Iowa's farmers union. Two representatives of organizations representing 17 i. 18 livestock producers who shall be jointly designated to the 19 department of natural resources by the Iowa pork producers 20 association, the Iowa cattlemens' association, the Iowa dairy 21 products association, the Iowa poultry association, and the 22 Iowa turkey federation. 23 The department of natural resources shall provide 2. 24 administrative support to the committee. The attorney general 25 shall appoint an assistant attorney general to provide the 26 committee with legal counsel and assistance. 27 In conducting its reevaluation, the committee shall only 3. 28 consider methods to better further the purpose of the master 29 matrix as specified in section 359.305, subsection 1, without 30 further restriction, including any restriction contained in 31 2002 Iowa Acts, ch. 1137, § 62, or any other restriction 32 provided in section 359.305. 33 4. The committee shall prepare a report, including findings

35 legislation and proposed revisions to 567 IAC chapter 65,

1 appendix C. The department on behalf of the committee shall 2 submit its report in an electronic format to the general 3 assembly not later than December 15, 2011. 4 Sec. 2. EFFECTIVE UPON ENACTMENT. This Act, being deemed of 5 immediate importance, takes effect upon enactment. 6 EXPLANATION 7 In 2002, the general assembly enacted S.F. 2293 (2002 8 Iowa Acts, chapter 1137) which in part established a new 9 procedure for approving or disapproving applications for the 10 construction or expansion of confinement feeding operations 11 by the department of natural resources in cooperation with 12 participating county boards of supervisors, based on a master 13 matrix (Code sections 459.304 and 459.305). The purpose of 14 the master matrix is to provide a comprehensive assessment 15 mechanism in order to produce a statistically verifiable basis 16 for determining whether to approve or disapprove an application 17 (Code section 359.305). The Act established a 10-member 18 technical advisory committee to recommend matrix categories, 19 criteria within the categories, and the point values assigned 20 to the criteria. The department adopted a master matrix 21 by rule (567 IAC chapter 65, appendix C). The committee's 22 function was to implement the statute. 23

This bill reestablishes the committee and provides that in conducting its reevaluation, it shall consider methods to better further the purpose of the master matrix as specified in Code section 359.305, subsection 1, without further restriction, including any restriction contained in 2002 Iowa Acts, chapter 1137, § 62 or Code section 459.305 (e.g., no 29 deduction of points).
