A BILL FOR

- 1 An Act relating to the licensure of persons engaged in fire
- 2 protection system installation, maintenance, repair,
- 3 service, or inspection.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 100C.6, subsection 4, Code Supplement
- 2 2009, is amended to read as follows:
- 3 4. Relieve any person engaged in fire sprinkler protection
- 4 system installation, maintenance, repair, service, or
- 5 inspection as defined in section 100D.1 from obtaining a fire
- 6 sprinkler protection system installer and maintenance worker
- 7 license as required pursuant to chapter 100D.
- 8 Sec. 2. Section 100D.1, subsections 1, 5, and 8, Code
- 9 Supplement 2009, are amended to read as follows:
- 10 1. "Apprentice sprinkler fitter" fire protection system
- 11 installer and maintenance worker" means a person who is
- 12 registered in an apprenticeship program approved by the
- 13 United States department of labor who is engaged in learning
- 14 the fire protection system industry trade under the direct
- 15 supervision of a responsible managing employee of a certified
- 16 fire extinguishing system contractor or licensed fire
- 17 sprinkler protection system installer and maintenance worker
- 18 and who is registered with the United States department of
- 19 labor, office of apprenticeship other than a trainee.
- 20 5. "Fire protection system" means a sprinkler, standpipe,
- 21 hose system, special hazard system, dry systems, foam systems,
- 22 or any water-based fire protection system, either whether
- 23 engineered or pre-engineered and whether manual or
- 24 automatically activated, used for fire protection purposes
- 25 that is composed of which may include an integrated system of
- 26 underground and overhead piping and which may be connected to
- 27 a water source. For licensing purposes only "fire protection
- 28 system does not include the water service piping to a structure
- 29 or building from a city water main.
- 30 8. "Fire sprinkler protection system installer and
- 31 maintenance worker" means a person who, having the necessary
- 32 qualifications, training, experience, and technical knowledge,
- 33 conducts fire protection system installation and maintenance,
- 34 and who is licensed by the department.
- 35 Sec. 3. Section 100D.1, Code Supplement 2009, is amended by

- 1 adding the following new subsections:
- 2 NEW SUBSECTION. 9. "Responsible managing employee" means
- 3 an owner, partner, officer, or manager employed full-time
- 4 by a fire extinguishing system contractor who is certified
- 5 by the national institute for certification in engineering
- 6 technologies at a level three in fire protection technology,
- 7 automatic sprinkler system layout, or another certification in
- 8 automatic sprinkler system layout recognized by rules adopted
- 9 by the fire marshal pursuant to section 100C.7 or who meets any
- 10 other criteria established by rule.
- 11 NEW SUBSECTION. 9A. "Routine maintenance" means the repair
- 12 or replacement of existing fire protection system components of
- 13 the same size and type for which no changes in configuration
- 14 are made, and does not include any new installation or the
- 15 expansion or extension of any existing fire protection system.
- 16 NEW SUBSECTION. 10. "Trainee" means a person who is engaged
- 17 in learning the fire protection system industry trade under
- 18 the direct supervision of a responsible managing employee of a
- 19 certified fire extinguishing system contractor or licensed fire
- 20 protection system installer and maintenance worker and who is
- 21 not registered with the United States department of labor.
- Sec. 4. Section 100D.2, subsections 1 and 2, Code Supplement
- 23 2009, are amended to read as follows:
- 24 l. On or after January 1, 2010, a person shall not perform
- 25 fire protection system installations or fire protection
- 26 system maintenance without holding a current, valid fire
- 27 sprinkler protection system installer and maintenance worker
- 28 license issued pursuant to this chapter., with the following
- 29 exceptions:
- 30 a. An employee of a fire extinguishing system contractor
- 31 working as an apprentice sprinkler fitter fire protection
- 32 system installer and maintenance worker performing fire
- 33 protection system installation or maintenance under the
- 34 direct supervision of an on-site responsible managing employee
- 35 or licensed fire sprinkler protection system installer and

- 1 maintenance worker is not required to hold a current, valid
- 2 fire sprinkler protection system installer and maintenance
- 3 worker license.
- 4 b. A person who installs or demolishes walls, ceilings,
- 5 flooring, insulation, or associated materials or a person who
- 6 demolishes sprinkler pipe fire protection system components is
- 7 not subject to the provisions of this chapter except when the
- 8 work involves a complete sprinkler system. A person is not
- 9 required to be licensed in order to demolish part of a system
- 10 or a partial system, provided that the system is taken out of
- ll service. If a system is restored to service after having been
- 12 taken out of service, the restoration work must be performed
- 13 by a person licensed pursuant to this chapter or a responsible
- 14 managing employee.
- 15 c. A person who is a responsible managing employee of a
- 16 fire extinguishing system contractor is not required to hold a
- 17 current, valid fire sprinkler protection system installer and
- 18 maintenance worker license, in order to perform fire protection
- 19 system installations or maintenance.
- 20 d. A trainee who works at all times under the direct
- 21 supervision of a licensed fire protection system installer and
- 22 maintenance worker, other than an unclassified person, may
- 23 be licensed to work on either special hazard fire protection
- 24 systems, pre-engineered fire protection systems, or both, but
- 25 shall not be licensed to perform installation or maintenance on
- 26 an engineered water-based fire protection system. A trainee
- 27 license may be renewed once and a person may work as a trainee
- 28 for a maximum of four years.
- 29 2. A licensed fire sprinkler protection system installer
- 30 and maintenance worker must be present at all locations
- 31 and at all times when fire protection system installation
- 32 work is being performed. At least one licensed fire
- 33 sprinkler protection system installer and maintenance
- 34 worker must be present for every three apprentice sprinkler
- 35 fitters fire protection system installers and maintenance

- 1 workers or trainees performing work related to fire protection
- 2 system installation.
- 3 Sec. 5. Section 100D.2, subsection 6, Code Supplement 2009,
- 4 is amended by striking the subsection.
- 5 Sec. 6. Section 100D.3, Code Supplement 2009, is amended to
- 6 read as follows:
- 7 100D.3 Fire sprinkler protection system installer and
- 8 maintenance worker license.
- 9 1. The state fire marshal shall issue a fire sprinkler
- 10 protection system installer and maintenance worker license to
- 11 an applicant who meets all of the following requirements:
- 12 a. Possesses a minimum of four years of employment
- 13 experience as an apprentice sprinkler fitter.
- 14 b. a. Has completed a United States department of
- 15 labor fire protection apprenticeship program approved by the
- 16 United States department of labor, or has completed two years
- 17 of full-time employment or the equivalent thereof as a trainee.
- 18 e, b. Is employed by a fire extinguishing system
- 19 contractor. However, an applicant whose work on extinguishing
- 20 systems will be restricted to systems on property owned or
- 21 controlled by the applicant's employer may obtain a license if
- 22 the employer is not a certified contractor.
- 23 d. c. Has received a passing score on the national
- 24 inspection, testing, and certification star fire sprinkler
- 25 mastery exam or on an equivalent exam from a nationally
- 26 recognized third-party testing agency that is approved by
- 27 the state fire marshal, or is certified at level one by
- 28 the national institute for certification in engineering
- 29 technologies based on general work elements, as defined
- 30 by the national institute for certification in engineering
- 31 technologies, and as specified by rule by the state fire
- 32 marshal, or is certified by another entity approved by the fire
- 33 marshal.
- 34 2. The holder of a fire sprinkler protection system
- 35 installer and maintenance worker license shall be responsible

- 1 for license fees, renewal fees, and continuing education hours.
- 2 3. The license of a fire sprinkler protection system
- 3 installer and maintenance worker licensee who ceases to be
- 4 employed by a fire extinguishing system contractor shall
- 5 continue to be valid until it would otherwise expire, but the
- 6 licensee shall not perform work requiring licensure under
- 7 this chapter until the licensee is again employed by a fire
- 8 extinguishing system contractor. If the licensee becomes
- 9 employed by a fire extinguishing system contractor other than
- 10 the contractor which employed the licensee at the time the
- ll license was issued, the licensee shall notify the fire marshal
- 12 and shall apply for an amendment to the license. The fire
- 13 marshal may establish by rule a fee for amending a license.
- 14 This subsection shall not extend the time period during which a
- 15 license is valid. This subsection does not apply to a licensee
- 16 whose work on extinguishing systems is restricted to systems on
- 17 property owned or controlled by the licensee's employer.
- 18 4. The fire marshal, by rule, may restrict the scope of work
- 19 authorized by a license.
- 20 Sec. 7. Section 100D.4, subsections 1 and 2, Code Supplement
- 21 2009, are amended to read as follows:
- 22 1. An applicant for a fire sprinkler protection
- 23 system installer and maintenance worker license or renewal of
- 24 an active license shall provide evidence of a public liability
- 25 insurance policy and surety bond in an amount determined
- 26 sufficient by the fire marshal by rule.
- 27 2. If the applicant is engaged in fire sprinkler protection
- 28 system installer and maintenance worker work individually
- 29 through a business conducted as a sole proprietorship, the
- 30 applicant shall personally obtain the insurance and surety
- 31 bond required by this section. If the applicant is engaged in
- 32 the fire sprinkler protection system installer and maintenance
- 33 worker business as an employee or owner of a legal entity,
- 34 then the insurance and surety bond required by this section
- 35 shall be obtained by the entity and shall cover all fire

- 1 sprinkler protection system installer and maintenance worker
- 2 work performed by the entity.
- 3 Sec. 8. Section 100D.5, subsection 1, Code Supplement 2009,
- 4 is amended to read as follows:
- 5 l. Adopt After consultation with the fire extinguishing
- 6 system contractors and alarm systems advisory board established
- 7 pursuant to section 100C.10, adopt rules pursuant to chapter
- 8 17A necessary for the administration and enforcement of this
- 9 chapter.
- 10 Sec. 9. Section 100D.8, Code Supplement 2009, is amended to
- ll read as follows:
- 12 100D.8 Provisional licensure.
- 13 1. An applicant for licensure under this chapter as a fire
- 14 sprinkler protection system installer and maintenance worker
- 15 who possesses a minimum of four years of experience as an
- 16 apprentice sprinkler fitter fire protection system installer
- 17 and maintenance worker and who has not successfully passed the
- 18 licensure examination or achieved certification as required
- 19 pursuant to section 100D.3 by January 1, 2010, shall be issued
- 20 a license as a fire sprinkler protection system installer and
- 21 maintenance worker for a period ending no later than June
- 22 30 December 31, 2010. A provisional license shall be granted
- 23 upon presentation of satisfactory evidence to the fire marshal
- 24 demonstrating experience and competency in conducting fire
- 25 protection system installations and fire protection system
- 26 maintenance according to criteria to be determined by the fire
- 27 marshal in rule.
- 28 2. An applicant issued a provisional license pursuant
- 29 to this section shall pass the licensure examination or
- 30 achieve certification on or before June 30 December 31, 2010,
- 31 in order to remain licensed as a fire sprinkler protection
- 32 system installer and maintenance worker. A provisional license
- 33 fee shall be established by the fire marshal by rule. No
- 34 provisional licenses shall be issued after April July 1, 2010.
- 35 Sec. 10. Section 100D.9, subsection 1, Code Supplement

- 1 2009, is amended to read as follows:
- 2 l. An applicant for licensure under this chapter, who
- 3 is employed as a fire sprinkler protection system installer
- 4 and maintenance worker as of July 1, 2008, shall be issued
- 5 a license upon presentation of satisfactory evidence to the
- 6 department of at least eight thousand five hundred hours of
- 7 experience as a fire sprinkler protection system installer and
- 8 maintenance worker and one of the following:
- 9 a. Presentation of a certificate of completion of a United
- 10 States department of labor, office of apprenticeship, four-year
- 11 or five-year protection system apprenticeship program, approved
- 12 by the United States department of labor.
- 13 b. A passing score on the national inspection, testing and
- 14 certification star fire sprinkler mastery exam or an equivalent
- 15 exam from a nationally recognized third-party testing agency
- 16 that is approved by the state fire marshal.
- 17 c. Certification, based upon general work elements,
- 18 as defined by the national institute for certification in
- 19 engineering technologies, at level I by the national institute
- 20 for certification in engineering technologies, and or another
- 21 entity as specified by rule by the state fire marshal.
- Sec. 11. Section 100D.10, Code Supplement 2009, is amended
- 23 to read as follows:
- 24 100D.10 Reciprocal licenses.
- 25 To the extent that another state provides for the licensing
- 26 of fire sprinkler protection system installers and maintenance
- 27 workers or similar action, the state fire marshal may issue
- 28 a fire sprinkler protection system installer and maintenance
- 29 worker license, without examination, to a nonresident fire
- 30 sprinkler protection system installer and maintenance worker
- 31 who has been licensed by such other state for at least three
- 32 years provided such other state grants the same reciprocal
- 33 licensing privileges to residents of Iowa who have obtained
- 34 a fire sprinkler protection system installer and maintenance
- 35 worker license upon payment by the applicant of the required

- 1 fee and upon furnishing proof that the qualifications of the
- 2 applicant are equal to the qualifications of holders of similar
- 3 licenses in this state.
- 4 Sec. 12. Section 100D.11, subsection 2, Code Supplement
- 5 2009, is amended to read as follows:
- 6 2. The provisions of this chapter shall not be construed
- 7 to apply to a person employed full time as a custodian for a
- 8 school corporation, hospital, or public facility, who performs
- 9 fire sprinkler maintenance work involving no more than one
- 10 sprinkler head or nozzle only performing routine maintenance.
- 11 Sec. 13. Section 100D.13, subsection 1, unnumbered
- 12 paragraph 1, Code Supplement 2009, is amended to read as
- 13 follows:
- 14 The state fire marshal may issue a temporary fire
- 15 sprinkler protection system installer and maintenance worker
- 16 license to a person, providing that all of the following
- 17 conditions are met:
- 18 Sec. 14. Section 100D.13, subsection 1, paragraphs a and e,
- 19 Code Supplement 2009, are amended to read as follows:
- 20 a. The person is currently licensed or certified to perform
- 21 work as a fire sprinkler protection system installer and
- 22 maintenance worker in another state.
- 23 e. The person intends to perform work as a fire
- 24 sprinkler protection system installer and maintenance worker
- 25 only in areas of this state which are covered by a disaster
- 26 emergency declaration issued by the governor pursuant to
- 27 section 29C.6.
- Sec. 15. Section 272C.1, subsection 6, paragraph af, Code
- 29 Supplement 2009, is amended to read as follows:
- 30 af. The department of public safety, in licensing fire
- 31 sprinkler protection system installers and maintenance workers
- 32 pursuant to chapter 100D.
- 33 EXPLANATION
- 34 Under current law, persons who perform fire protection
- 35 system installation or fire protection system maintenance must

- 1 be licensed as a fire sprinkler installer and maintenance
- 2 worker. This bill changes that designation to fire protection
- 3 system installer and maintenance worker.
- 4 The bill also revises apprenticeship requirements for
- 5 trainees. The bill eliminates references to a four-year
- 6 apprenticeship and instead requires completion of a fire
- 7 protection apprenticeship program approved by the United States
- 8 department of labor, or completion of two years of full-time
- 9 employment as a trainee. Under the bill the fire marshal, by
- 10 rule, may restrict the scope of work authorized by a license.
- 11 The bill eliminates a current provision which allows a
- 12 governmental subdivision that administers an inspection program
- 13 relating to the installation of a fire protection system on
- 14 July 31, 2009, to continue that inspection program.
- 15 The bill provides that persons who demolish part of a system
- 16 do not need to be licensed, if the system is taken out of
- 17 service. The bill also allows a company manager to supervise
- 18 the work of an apprentice or to perform system restoration
- 19 work, if the manager is certified in fire protection
- 20 technology.
- 21 The bill eliminates current language which exempts from the
- 22 Code chapter custodians in schools, hospitals, and government
- 23 facilities performing sprinkler maintenance. The bill adds a
- 24 general exemption for routine maintenance.
- 25 The bill extends the period for temporary licensure, pending
- 26 passage of the examination, from June 30, 2010, to December 31,
- 27 2010.
