Section 1. <u>NEW SECTION</u>. 256G.1 LEGISLATIVE INTENT. It is the intent of the general assembly to develop a state 3 research and development prekindergarten through grade twelve 1 4 school in order to do the following:

- 1. To raise and sustain the level of all prekindergarten 6 through grade twelve students' educational attainment and 7 personal development through innovative and promising teaching 8 practice.
- 1 9 2. To enhance the preparation and professional competence 1 10 of the educators in this state through collaborative inquiry 1 11 and exchange of professional knowledge in teaching and 1 12 learning.
- 1 13 3. To focus on research that transforms teaching practice 1 14 to meet the changing needs of this state's educational system. Sec. 2. <u>NEW SECTION</u>. 256G.2 DEFINITIONS. 1 15 1 16

- For purposes of this chapter:

  1. "Department" means the department of education.
- "Department" means the department of the department of 1 19 education.
- 1 20 3. "President" means the president of the university of 1 21 northern Iowa.
- 4. "Research and development school" means a 23 prekindergarten through grade twelve research, development, 1 24 demonstration, and dissemination school using expanded 1 25 facilities at the center for early development education, also
- 1 26 known as the Price laboratory school, in Cedar Falls.
  1 27 5. "University" means the university of northern Iowa.
  1 28 Sec. 3. NEW SECTION. 256G.3 RESEARCH AND DEVELOPMENT 1 29 SCHOOL FUNDING.
- 30 1. a. The research and development school shall be 1 31 eliqible for the school foundation aid program under chapter 1 32 257.
- 33 The research and development school shall maintain a 34 basic geographic boundary line agreement with the Cedar Falls 1 35 community school district.
  - c. Open enrollment under section 282.18 applies to the 2 research and development school.
  - 2. To the same extent and under the same circumstances as 4 if the research and development school were a school district, 5 the research and development school shall be eligible to 6 receive funds from the secure an advanced vision for education 7 fund under section 423F.2 for infrastructure purposes as 8 allowed under section 423F.3.
- 3. The school budget review committee may grant 2 10 supplemental funding to the research and development school 2 11 for its research component if additional runging beyond che
  2 12 funding provided by the university is necessary under section
  2 13 257.31, subsection 5, paragraph "o".
  2 14 4. Funds provided by the university for the center for
  2 15 control development education under section 262.71 shall be
- 2 16 redirected as applicable to support the research component at 2 17 the research and development school.

1. The university shall be the governing entity of the 2 21 research and design school and as such shall be responsible

2 22 for the faculty, facility, grounds, and staffing.
2 23 2. The department shall be the accreditation agency and as 2 23 2 24 such shall serve as the authority on teacher qualification 25 requirements and waiver provisions.

3. a. A fifteen=member advisory council is created, composed of the following members:

- Eight members shall be jointly recommended for (2) 34 membership by the president and the director and shall be 35 jointly approved by the state board of regents and the state 1 board of education, shall serve three=year staggered terms, 2 and shall be eligible to serve for two consecutive three=year 3 terms on the council in addition to any partial, initial term:
- (a) One member representing prekindergarten through grade 5 twelve teachers.
  - (b) One member representing prekindergarten through grade twelve administrators.
    - (C) One member representing area education agencies.
- One member representing Iowa state university of (d) 10 science and technology.
  - One member representing the university of Iowa. (e)
- One member representing parents of students at the (f) 3 13 research and development school.

One member representing business and industry.
One member representing private colleges in the state. (h)

- Four members of the general assembly serving as ex 3 17 officio, nonvoting members, one representative to be appointed 3 18 by the speaker of the house of representatives, one 3 19 representative to be appointed by the minority leader of the 3 20 house of representatives, one senator to be appointed by the 21 majority leader of the senate after consultation with the 3 22 president of the senate, and one senator to be appointed by
- 3 23 the minority leader of the senate.
  3 24 b. (1) The advisory council shall review and evaluate the
  3 25 educational processes and results of the research and 3 26 development school.
- (2) The advisory council shall provide an annual report to 28 the president, the director, the state board of regents, and 3 29 the state board of education.
- 4. a. A nine=member standing institutional research 31 committee, appointed by the president and the director, is 3 32 created, composed of the following members:

  - 34 development school or the person designated with this 35 responsibility.
  - (2) One member representing the university of northern 2 Iowa.
    - One member representing Iowa state university of (3) science and technology.
      - (4)One member representing the university of Iowa.
      - (5)One member representing business and industry.
    - (6) One member representing prekindergarten through grade twelve students.
      - (7) One member representing the political community.
      - (8)One member representing the department.
      - One member representing private colleges in the state. (9)
  - The appointed members should collectively possess the b. 13 following characteristics:
    - (1) Be well informed about the educational needs of students in the state.
    - (2) Be aware of and understand the standards and protocol for educational research.
    - (3) Understand the dissemination of prekindergarten through grade twelve research results.
      - Understand the impact of educational research.
- (5) Be knowledgeable about compliance with human subject 4 21 22 protection protocol.
- c. The committee shall serve as the clearinghouse for the 4 24 investigative and applied research at the research and 4 25 development school.
- 4 26 d. The committee shall create research protocols, approve 27 research proposals, review the quality and results of 4 28 performed research, and provide support for dissemination 4 29 efforts.

4 30 Section 257.31, subsection 5, Code 2009, is 4 31 amended by adding the following new paragraph: NEW PARAGRAPH. o. Lack of funding for research at the 4 33 research and development school established under chapter 4 34 256G. Sec. 6. RESEARCH AND DEVELOPMENT SCHOOL INFRASTRUCTURE.

1. a. There is appropriated from the general fund of the 35 2 state to the university of northern Iowa for the fiscal year 3 beginning July 1, 2009, and ending June 30, 2010, the

4 following amount, or so much thereof as is necessary, to be 5 used for the purposes designated: For a contract with a design firm to evaluate the condition of the center for early development education in Cedar Falls 8 and determine an approximate cost of both renovation of the current facility and new construction with a recommendation as

10 to which is more feasible: 5 11 ..... \$ 35 5 12 b. The design firm's recommendation shall consider the

5 13 following property elements:

(1) Grounds, utility, and paving systems.(2) Exterior systems, including the roof, walls, windows, 5 16 exterior doors, and structural components.

(3) Interior systems, including walls, doors, floors, and 5 18 ceilings.

Fire and life safety issues. (4)

(5) Readily achievable design features meeting the 5 21 requirements of the federal Americans With Disabilities Act.

Heating, ventilation, and air conditioning including 5 23 control mechanisms.

- (7) Electrical and electrical distribution system.
- (8) Plumbing.

- (9) Fire protection.
- (10) Elevators.

The design firm shall report in fiscal year 2010=2011 5 30 to the president, the director, and the transition team the 31 results of its evaluation and recommendation.

2. The renovation or rebuilding of the center for early 5 33 development education shall be funded from a direct 34 appropriation from the rebuild Iowa infrastructure fund 35 created in section 8.57. Leadership in energy and 1 environmental design certification shall be sought in order 2 that the research and development school serve as a model of 3 energy efficiency and design.

3. A three=year timeline to establish the research and 5 development school is proposed for the university and the 6 department. A transition team, appointed by the president and 7 the director, shall develop and implement specific transition 8 plans for the first year of the transition and for the entire 9 three=year transition period in order to establish a 10 functioning research and development school at the end of the 6 11 transition period. The transition team shall use the 6 12 recommendations for each year of the transition as submitted 6 13 in the report of the committees required by 2008 Iowa Acts, 6 14 chapter 1101, to oversee the transition.

## EXPLANATION

This bill provides for the establishment of a state 17 research and development prekindergarten though grade 12 6 18 school based on a three=year transition plan. The bill sets 6 19 out the basic structure of the school, including the 6 20 legislative intent, the school's basic funding, the school's 21 governance, and the school's infrastructure.

The research and development school's funding would include 23 being eligible for school foundation aid; funding from the 24 secure an advanced vision for education fund; additional 6 25 research funding, if needed, from the school budget review 6 26 committee; and funding from the university of northern Iowa 27 (UNI) that currently supports the Price laboratory school. 28 The bill sets out the research and development school's

6 29 governance such that UNI governs the facility, faculty, 30 staffing, and grounds. The department of education is 31 responsible for accrediting the teachers and staff. 6 32 15-member advisory council will review and evaluate the 33 educational processes and results of the school. 34 nine=member standing institutional research committee will 35 serve as the clearinghouse for the investigative and applied 1 research at the school, including creating research protocols, 2 approving research proposals, and reviewing the quality and 3 results of performed research.

The research and development school's infrastructure is 5 based on a three=year transition plan from the current Price 6 laboratory school. The bill calls for a design firm to be
7 hired to evaluate the current school facility and determine
8 whether renovation or new construction is the most feasible
9 option. The design firm's report is due in FY 2010=2011 and
10 the bill makes an appropriation of \$35,000 for the cost of the
11 evaluation.
12 The bill states that the cost of renovation or rebuilding
13 for the school shall be funded from the rebuild Iowa
14 infrastructure fund and that leadership in energy and
15 environmental design certification be sought.
16 The bill requires that a three=year timeline be established
17 and that a transition team be appointed in order to have a
18 functioning research and development school at the end of
19 three years.
