A BILL FOR

- 1 An Act relating to the organization and duties of the state
- 2 board of health.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 136.1, Code 2009, is amended to read as 2 follows:
- 3 136.1 Composition of board.
- 4 The state board of health shall consist of the following
- 5 members: Five Two members learned in health-related
- 6 disciplines, three members who have direct experience with
- 7 public health, two members who have direct experience with
- 8 substance abuse treatment or prevention, and four members
- 9 representing the general public.
- 10 The director of public health shall serve as secretary of the
- 11 board.
- 12 Sec. 2. Section 136.3, Code 2009, is amended by striking the
- 13 section and inserting in lieu thereof the following:
- 14 136.3 Duties.
- 15 The state board of health shall provide a forum for the
- 16 development of public health policy in the state of Iowa and
- 17 shall have the following powers and duties:
- 18 1. Consider and study legislation and administration
- 19 concerning public health.
- 20 2. Advise the department on any issue related to the
- 21 promotion and protection of the health of Iowans including but
- 22 not limited to:
- 23 a. Prevention of epidemics and the spread of disease,
- 24 including communicable and infectious diseases such as zoonotic
- 25 diseases, quarantine and isolation, sexually transmitted
- 26 diseases, and antitoxins and vaccines.
- 27 b. Protection against environmental hazards.
- 28 c. Prevention of injuries.
- 29 d. Promotion of healthy behaviors.
- 30 e. Preparing for, responding to, and recovering from public
- 31 health emergencies and disasters.
- 32 3. Establish policies governing the performance of the
- 33 department in the discharge of any duties imposed on it by law.
- 34 4. Provide guidance to the director in the discharge of the
- 35 director's duties.

- 1 5. Adopt and implement the Iowa public health standards.
- Assure that the department complies with Iowa Code,
- 3 administrative rules, and the Iowa public health standards.
- 4 For this purpose the board shall have access at any time to all
- 5 documents and records of the department.
- 6 7. Assure that the department prepares and distributes an 7 annual report.
- 8 8. Advise or make recommendations to the director of public
- 9 health, governor, and general assembly relative to public
- 10 health and advocate for state and local public health to comply
- 11 with the Iowa public health standards.
- 9. Offer consultation to the governor in the appointment of
- 13 the director of the department.
- 14 10. Adopt, promulgate, amend, and repeal rules and
- 15 regulations consistent with law for the protection of the
- 16 public health and prevention of substance abuse, and for
- 17 the guidance of the department. All rules adopted by the
- 18 department are subject to approval by the board.
- 19 11. Act by committee, or by a majority of the board.
- 20 12. Keep minutes of the transactions of each session,
- 21 regular or special, which shall be public records and filed
- 22 with the department.
- 23 13. Perform those duties authorized pursuant to chapter
- 24 125. The board may appoint a substance abuse program committee
- 25 to approve or deny applications for licensure received from
- 26 substance abuse programs pursuant to chapter 125 and to perform
- 27 any other function authorized by chapter 125 and delegated to
- 28 the committee.
- 29 14. Perform those duties authorized pursuant to sections
- 30 135.156, 135.159, and 135.161, and other provisions of law.
- 31 Sec. 3. Section 136.5, Code 2009, is amended to read as
- 32 follows:
- 33 **136.5** Meetings.
- 34 The board shall meet on the second Wednesday in July and on
- 35 the second Wednesday of every second month thereafter at least

- 1 six times per year and at such other times as may be deemed
- 2 necessary by the president chairperson of the board or the
- 3 director of the department. The president department shall
- 4 give each board member adequate notice of all special meetings.
- 5 A majority of the members of the board shall constitute a 6 quorum.
- 7 Sec. 4. Section 136.7, Code 2009, is amended to read as 8 follows:
- 9 136.7 Officer Chairperson staff assistance.
- 10 At the meeting held in The board shall annually in July of
- 11 each year a president shall be elected from the board elect
- 12 <u>a chairperson</u>, who shall serve for a period of one year. At
- 13 the request of the board the The department shall furnish
- 14 an executive clerk staff from the regular employees of the
- 15 department to record the minutes of the meetings of the board.
- 16 Sec. 5. Section 136.8, Code 2009, is amended to read as
- 17 follows:
- 18 **136.8** Supplies.
- 19 The department shall furnish the board of health with all
- 20 articles and supplies required for the public use and necessary
- 21 to enable the board to perform the duties imposed upon it by
- 22 law. Such articles and supplies shall be obtained by the
- 23 department in the same manner in which the regular supplies for
- 24 the department are obtained and the same shall be considered
- 25 and accounted for as if obtained for the use of the department.
- 26 EXPLANATION
- 27 This bill rewrites provisions in Code chapter 136, relating
- 28 to the organization and duties of the state board of health.
- 29 The revision remains very similar to the current statute.
- 30 The bill revises the membership of the board itself. Under
- 31 current law, the board consists of five members learned
- 32 in health-related disciplines, two members who have direct
- 33 experience with substance abuse treatment or prevention, and
- 34 four members representing the general public. Under the bill,
- 35 board makeup consists of two members learned in health-related

- 1 disciplines, three members who have direct experience with
- 2 public health, two members who have direct experience with
- 3 substance abuse treatment or prevention, and four members
- 4 representing the general public.
- 5 The bill amends Code section 136.3, relating to the duties
- 6 of the board, by reorganizing the Code section and updating
- 7 language. The bill eliminates some specific duties and sets
- 8 the board duties in general terms. Many of the specific duties
- 9 are now encompassed in the board duty to "[a]dopt and implement
- 10 the Iowa public health standards".
- 11 The bill revises Code section 136.5 to provide general
- 12 guidelines for the number of meetings the board shall hold
- 13 annually rather than specific meeting dates and directs the
- 14 department, rather than the president of the board, to give
- 15 notice of meetings. The bill also amends Code section 136.7 to
- 16 provide that the board shall elect a chairperson rather than a
- 17 president.
