- 1 An Act relating to the licensure of persons engaged in fire
- 2 protection system installation, maintenance, repair,
- 3 service, or inspection.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 100C.6, subsection 4, Code Supplement
- 2 2009, is amended to read as follows:
- Relieve any person engaged in fire sprinkler protection
- 4 system installation, maintenance, repair, service, or
- 5 inspection as defined in section 100D.1 from obtaining a fire
- 6 sprinkler protection system installer and maintenance worker
- 7 license as required pursuant to chapter 100D.
- 8 Sec. 2. Section 100D.1, subsections 1, 5, and 8, Code
- 9 Supplement 2009, are amended to read as follows:
- 10 1. "Apprentice sprinkler fitter" fire protection system
- 11 installer and maintenance worker" means a person who is
- 12 registered in an apprenticeship program approved by the
- 13 United States department of labor who is engaged in learning
- 14 the fire protection system industry trade under the direct
- 15 supervision of a responsible managing employee of a certified
- 16 fire extinguishing system contractor or licensed fire
- 17 sprinkler protection system installer and maintenance worker
- 18 and who is registered with the United States department of
- 19 labor, office of apprenticeship other than a trainee.
- 20 5. "Fire protection system" means a sprinkler, standpipe,
- 21 hose system, special hazard system, dry systems, foam systems,
- 22 or any water-based fire protection system, either whether
- 23 engineered or pre-engineered and whether manual or
- 24 automatically activated, used for fire protection purposes
- 25 that is composed of which may include an integrated system of
- 26 underground and overhead piping and which may be connected to
- 27 a water source. For licensing purposes only "fire protection
- 28 system" does not include the water service piping to a structure
- 29 or building from a city water main.
- 30 8. "Fire sprinkler protection system installer and
- 31 maintenance worker" means a person who, having the necessary
- 32 qualifications, training, experience, and technical knowledge,
- 33 conducts fire protection system installation and maintenance,
- 34 and who is licensed by the department.

- 9 automatic sprinkler system layout recognized by rules adopted
- 10 by the fire marshal pursuant to section 100C.7 or who meets any
- ll other criteria established by rule.
- 12 NEW SUBSECTION. 10. "Trainee" means a person who is engaged
- 13 in learning the fire protection system industry trade under
- 14 the direct supervision of a responsible managing employee of a
- 15 certified fire extinguishing system contractor or licensed fire
- 16 protection system installer and maintenance worker and who is
- 17 not registered with the United States department of labor.
- 18 Sec. 4. Section 100D.2, subsections 1 and 2, Code Supplement
- 19 2009, are amended to read as follows:
- On or after January 1, 2010, a person shall not perform
- 21 fire protection system installations or fire protection
- 22 system maintenance without holding a current, valid fire
- 23 sprinkler protection system installer and maintenance worker
- 24 license issued pursuant to this chapter., with the following
- 25 exceptions:
- 26 a. An employee of a fire extinguishing system contractor
- 27 working as an apprentice sprinkler fitter fire protection
- 28 system installer and maintenance worker performing fire
- 29 protection system installation or maintenance under the
- 30 direct supervision of an on-site responsible managing employee
- 31 or licensed fire sprinkler protection system installer and
- 32 maintenance worker is not required to hold a current, valid
- 33 fire sprinkler protection system installer and maintenance
- 34 worker license.
- 35 b. A person who installs or demolishes walls, ceilings,
- 1 flooring, insulation, or associated materials or a person who

- 2 demolishes sprinkler pipe fire protection system components is
- 3 not subject to the provisions of this chapter except when the

- 5 required to be licensed in order to demolish part of a system
- 6 or a partial system, provided that the system is taken out of
- 7 service. If a system is restored to service after having been
- 8 taken out of service, the restoration work must be performed
- 9 by a person licensed pursuant to this chapter or a responsible
- 10 managing employee.
- 11 c. A person who is a responsible managing employee of a
- 12 fire extinguishing system contractor is not required to hold a
- 13 current, valid fire sprinkler protection system installer and
- 14 maintenance worker license, in order to perform fire protection
- 15 system installations or maintenance.
- 16 d. A trainee who works at all times under the direct
- 17 supervision of a licensed fire protection system installer and
- 18 maintenance worker, other than an unclassified person, may
- 19 be licensed to work on either special hazard fire protection
- 20 systems, pre-engineered fire protection systems, or both, but
- 21 shall not be licensed to perform installation or maintenance on
- 22 an engineered water-based fire protection system. A trainee
- 23 license may be renewed once and a person may work as a trainee
- 24 for a maximum of four years.
- 25 2. A licensed fire sprinkler protection system installer
- 26 and maintenance worker must be present at all locations
- 27 and at all times when fire protection system installation
- 28 work is being performed. At least one licensed fire
- 29 sprinkler protection system installer and maintenance
- 30 worker must be present for every three apprentice sprinkler
- 31 fitters fire protection system installers and maintenance
- 32 workers or trainees performing work related to fire protection
- 33 system installation.
- 34 Sec. 5. Section 100D.2, subsection 6, Code Supplement 2009,
- 35 is amended by striking the subsection.
- 1 Sec. 6. Section 100D.3, Code Supplement 2009, is amended to

- 3 100D.3 Fire sprinkler protection system installer and 4 maintenance worker license.
- 5 l. The state fire marshal shall issue a fire sprinkler
- 6 protection system installer and maintenance worker license to
- 7 an applicant who meets all of the following requirements:
- 8 a. Possesses a minimum of four years of employment
- 9 experience as an apprentice sprinkler fitter.
- 10 b. a. Has completed a United States department of
- 11 labor fire protection apprenticeship program approved by the
- 12 United States department of labor, or has completed two years
- 13 of full-time employment or the equivalent thereof as a trainee.
- 14 e, b. Is employed by a fire extinguishing system
- 15 contractor. However, an applicant whose work on extinguishing
- 16 systems will be restricted to systems on property owned or
- 17 controlled by the applicant's employer may obtain a license if
- 18 the employer is not a certified contractor.
- 19 d_{r} c. Has received a passing score on the national
- 20 inspection, testing, and certification star fire sprinkler
- 21 mastery exam or on an equivalent exam from a nationally
- 22 recognized third-party testing agency that is approved by
- 23 the state fire marshal, or is certified at level one by
- 24 the national institute for certification in engineering
- 25 technologies based on general work elements, as defined
- 26 by the national institute for certification in engineering
- 27 technologies, and as specified by rule by the state fire
- 28 marshal, or is certified by another entity approved by the fire
- 29 marshal.
- 30 2. The holder of a fire sprinkler protection system
- 31 installer and maintenance worker license shall be responsible
- 32 for license fees, renewal fees, and continuing education hours.
- The license of a fire sprinkler protection system
- 34 installer and maintenance worker licensee who ceases to be
- 35 employed by a fire extinguishing system contractor shall
- 1 continue to be valid until it would otherwise expire, but the

- 2 licensee shall not perform work requiring licensure under
- 3 this chapter until the licensee is again employed by a fire
- 4 extinguishing system contractor. If the licensee becomes
- 5 employed by a fire extinguishing system contractor other than
- 6 the contractor which employed the licensee at the time the
- 7 license was issued, the licensee shall notify the fire marshal
- 8 and shall apply for an amendment to the license. The fire
- 9 marshal may establish by rule a fee for amending a license.
- 10 This subsection shall not extend the time period during which a
- 11 license is valid. This subsection does not apply to a licensee
- 12 whose work on extinguishing systems is restricted to systems on
- 13 property owned or controlled by the licensee's employer.
- 4. The fire marshal, by rule, may restrict the scope of work
- 15 authorized by a license.

- 24 system installer and maintenance worker work individually
- 25 through a business conducted as a sole proprietorship, the
- 26 applicant shall personally obtain the insurance and surety
- 27 bond required by this section. If the applicant is engaged in
- 28 the fire sprinkler protection system installer and maintenance
- 29 worker business as an employee or owner of a legal entity,
- 30 then the insurance and surety bond required by this section
- 31 shall be obtained by the entity and shall cover all fire
- 32 sprinkler protection system installer and maintenance worker

- 6 Sec. 9. Section 100D.8, Code Supplement 2009, is amended to
- 7 read as follows:
- 8 100D.8 Provisional licensure.
- 9 1. An applicant for licensure under this chapter as a fire
- 10 sprinkler protection system installer and maintenance worker
- 11 who possesses a minimum of four years of experience as an
- 12 apprentice sprinkler fitter fire protection system installer
- 13 and maintenance worker and who has not successfully passed the
- 14 licensure examination or achieved certification as required
- 15 pursuant to section 100D.3 by January 1, 2010, shall be issued
- 16 a license as a fire sprinkler protection system installer and
- 17 maintenance worker for a period ending no later than June
- 18 30 December 31, 2010. A provisional license shall be granted
- 19 upon presentation of satisfactory evidence to the fire marshal
- 20 demonstrating experience and competency in conducting fire
- 21 protection system installations and fire protection system
- 22 maintenance according to criteria to be determined by the fire
- 23 marshal in rule.
- 24 2. An applicant issued a provisional license pursuant
- 25 to this section shall pass the licensure examination or
- 26 achieve certification on or before June 30 December 31, 2010,
- 27 in order to remain licensed as a fire sprinkler protection
- 28 system installer and maintenance worker. A provisional license
- 29 fee shall be established by the fire marshal by rule. No
- 30 provisional licenses shall be issued after April July 1, 2010.

- 33 1. An applicant for licensure under this chapter, who
- 34 is employed as a fire sprinkler protection system installer
- 35 and maintenance worker as of July 1, 2008, shall be issued
- 1 a license upon presentation of satisfactory evidence to the

- 3 experience as a fire sprinkler protection system installer and
- 4 maintenance worker and one of the following:
- 5 a. Presentation of a certificate of completion of a United
- 6 States department of labor, office of apprenticeship, four-year

- 8 by the United States department of labor.
- 9 b. A passing score on the national inspection, testing and
- 10 certification star fire sprinkler mastery exam or an equivalent

- 20 100D.10 Reciprocal licenses.
- 21 To the extent that another state provides for the licensing
- 22 of fire sprinkler protection system installers and maintenance
- 23 workers or similar action, the state fire marshal may issue
- 24 a fire sprinkler protection system installer and maintenance
- 25 worker license, without examination, to a nonresident fire
- 26 sprinkler protection system installer and maintenance worker
- 27 who has been licensed by such other state for at least three
- 28 years provided such other state grants the same reciprocal
- 29 licensing privileges to residents of Iowa who have obtained
- 30 a fire sprinkler protection system installer and maintenance
- 31 worker license upon payment by the applicant of the required
- 32 fee and upon furnishing proof that the qualifications of the
- 33 applicant are equal to the qualifications of holders of similar
- 34 licenses in this state.
- 1 Sec. 12. Section 100D.11, subsection 2, Code Supplement
- 2 2009, is amended to read as follows:

- 32 EXPLANATION
- 33 Under current law, persons who perform fire protection
- 34 system installation or fire protection system maintenance must
- 35 be licensed as a fire sprinkler installer and maintenance
- 1 worker. This bill changes that designation to fire protection
- 2 system installer and maintenance worker.

- 3 The bill also revises apprenticeship requirements for
- 4 trainees. The bill eliminates references to a four-year
- 5 apprenticeship and instead requires completion of a fire
- 6 protection apprenticeship program approved by the United States
- 7 department of labor, or completion of two years of full-time
- 8 employment as a trainee. Under the bill the fire marshal, by
- 9 rule, may restrict the scope of work authorized by a license.
- 10 The bill eliminates a current provision which allows a
- 11 governmental subdivision that administers an inspection program
- 12 relating to the installation of a fire protection system on
- 13 July 31, 2009, to continue that inspection program.
- 14 The bill provides that persons who demolish part of a system
- 15 do not need to be licensed, if the system is taken out of
- 16 service. The bill also allows a company manager to supervise
- 17 the work of an apprentice or to perform system restoration
- 18 work, if the manager is certified in fire protection
- 19 technology.
- 20 The bill extends the period for temporary licensure, pending
- 21 passage of the examination, from June 30, 2010, to December 31,
- 22 2010.
