A BILL FOR

- 1 An Act concerning the purchasing of raffle tickets.
- 2 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

S.F. 2217

- 1 Section 1. Section 99B.17, Code 2009, is amended to read as 2 follows:
- 3 99B.17 Gambling on credit unlawful exception.
- A person who tenders and a person who receives any
- 5 promise, agreement, note, bill, bond, contract, mortgage or
- 6 other security, or any negotiable instrument, as consideration
- 7 for any wager or bet, whether or not lawfully conducted or
- 8 engaged in pursuant to this chapter, commits a misdemeanor.
- 9 However, a participant in a bingo occasion or in a contest
- 10 lawful under section 99B.11 may make payment by personal check
- 11 for any entry or participation fee assessed by the sponsor of
- 12 the bingo occasion or contest.
- 2. a. A participant in a raffle conducted by an eligible
- 14 qualified organization may purchase raffle tickets by personal
- 15 check, money order, bank check, cashier's check, electronic
- 16 check, credit card, or debit card for one raffle conducted by
- 17 the eligible qualified organization during a calendar year.
- 18 The department shall adopt rules setting minimum standards
- 19 concerning the purchase of raffle tickets as authorized
- 20 by this section for the protection of personal information
- 21 consistent with payment card industry compliance regulations.
- 22 For purposes of this subsection, an "eligible qualified
- 23 organization is a qualified organization that has conducted
- 24 a raffle pursuant to section 99B.7 during the previous eight
- 25 consecutive calendar years in which the net proceeds are
- 26 distributed to a museum.
- 27 b. The department shall adopt rules setting minimum
- 28 standards concerning the purchase of raffle tickets as
- 29 authorized by this subsection for the protection of personal
- 30 information consistent with payment card industry regulations.
- 31 EXPLANATION
- 32 This bill authorizes a participant in a raffle conducted
- 33 by an eligible qualified organization to purchase raffle
- 34 tickets by check, money order, credit card, or debit card for
- 35 one raffle per calendar year. The bill defines an eligible

- 1 qualified organization as a qualified organization that has
- 2 conducted a raffle during the previous eight consecutive
- 3 calendar years in which the net proceeds are distributed to a
- 4 museum. Current law makes it a misdemeanor to gamble or wager
- 5 on credit. The bill requires the department of inspections
- 6 and appeals to adopt rules regarding the purchase of raffle
- 7 tickets on credit to include protection of personal information
- 8 consistent with payment card industry regulations.
