SENATE FILE 2241 BY RAGAN

A BILL FOR

- 1 An Act relating to utilization of environmentally preferable
- 2 cleaning and maintenance products in school facilities and
- 3 state buildings.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. 135.23 Building cleaning and
- 2 maintenance environmentally preferable cleaning products.
- 3 1. Findings and intent. The general assembly finds that
- 4 human beings are vulnerable to and may be severely affected by
- 5 exposure to chemicals, hazardous waste, and other environmental
- 6 hazards. The federal environmental protection agency estimates
- 7 that human exposure to indoor air pollutants can be two to five
- 8 times, and up to one hundred times, higher than outdoor levels.
- 9 Children, teachers, janitors, and other staff members spend a
- 10 significant amount of time inside school buildings. Likewise,
- 11 state employees and citizens of this state spend a significant
- 12 amount of time inside state buildings. These individuals
- 13 are continuously exposed to chemicals from cleaners, waxes,
- 14 deodorizers, and other maintenance products.
- 2. Definitions. As used in this section, unless the context
- 16 otherwise requires:
- 17 a. "Environmentally preferable" means cleaning and
- 18 maintenance products which meet the policy guidelines and
- 19 specifications established by the department by rule pursuant
- 20 to subsection 4.
- 21 b. "State building" means a public facility or building
- 22 owned by or leased by the state, or an agency or department of
- 23 the state.
- 3. Use of environmentally preferable cleaning products. All
- 25 school districts in this state, and state agencies utilizing
- 26 state buildings, are encouraged to voluntarily conform to
- 27 an environmentally preferable cleaning policy designed to
- 28 facilitate the purchase and use of environmentally preferable
- 29 cleaning products for purposes of public school and state
- 30 building cleaning and maintenance. The policy shall apply
- 31 to school districts and state agencies on a mandatory basis
- 32 beginning July 1, 2012, subject to the exemption provisions
- 33 contained in this subsection. School districts and state
- 34 agencies procuring supplies for schools and state buildings may
- 35 deplete their existing cleaning and maintenance supply stocks

- 1 and implement the new requirements in the procurement cycle
- 2 for the following year. On or after July 1, 2012, a school
- 3 district or state agency is exempt from the requirements of
- 4 this section if the school district or state agency submits
- 5 written documentation to the department on an annual basis that
- 6 adoption of the policy would result in a significant increase
- 7 in annual cleaning and maintenance product and supply costs.
- 8 4. Policy quidelines and specifications.
- 9 a. The department shall establish by rule and update on a
- 10 semiannual basis thereafter guidelines and specifications for
- 11 the use of environmentally preferable cleaning and maintenance
- 12 products in school and state buildings.
- 13 b. The department shall provide multiple avenues by which
- 14 cleaning and maintenance products, equipment, and supplies
- 15 may be determined to be environmentally preferable under the
- 16 guidelines and specifications.
- 17 (1) Manufacturers may submit documentation that products
- 18 have been tested and certified by a nationally recognized
- 19 organization which establishes environmental standards.
- 20 (2) Alternatively, manufacturers may submit an affidavit
- 21 stating that products meet the requirements of a nationally
- 22 recognized organization which establishes environmental
- 23 standards.
- 24 (3) Manufacturers may also submit an affidavit stating that
- 25 products have undergone a comparative life-cycle assessment
- 26 that was conducted in accordance with requirements established
- 27 by a nationally recognized organization which establishes
- 28 environmental standards.
- 29 c. The guidelines and specifications established pursuant
- 30 to this section shall not prohibit the use of disinfectants,
- 31 disinfecting cleaners, sanitizers, or any other antimicrobial
- 32 product regulated by the federal Insecticide, Fungicide,
- 33 and Rodenticide Act, 7 U.S.C. § 136 et seq., when necessary
- 34 to protect public health and provided that the use of these
- 35 products is in accordance with responsible cleaning procedure

1 requirements.

- d. Guidelines and specifications shall be established
- 3 by rule after a review and evaluation of existing research
- 4 by the department, and shall be completed no later than one
- 5 hundred eighty days after the effective date of this Act. The
- 6 guidelines and specifications shall include implementation
- 7 practices, including inspection procedures and evaluation
- 8 criteria. The completed guidelines and specifications shall be
- 9 posted and updated on the department's internet site, and shall
- 10 additionally be distributed on an updated basis to each school
- 11 district.
- 12 Sec. 2. STATE MANDATE FUNDING SPECIFIED. In accordance
- 13 with section 25B.2, subsection 3, the state cost of requiring
- 14 compliance with any state mandate included in this Act shall be
- 15 paid by a public school district from state school foundation
- 16 aid received by the school district under section 257.16.
- 17 This specification of the payment of the state cost shall be
- 18 deemed to meet all of the state funding-related requirements of
- 19 section 25B.2, subsection 3, and no additional state funding
- 20 shall be necessary for the full implementation of this Act
- 21 by and enforcement of this Act against all affected school
- 22 districts.
- 23 EXPLANATION
- 24 This bill requires school districts and state agencies
- 25 to purchase and utilize environmentally preferable cleaning
- 26 products for purposes of cleaning and maintenance beginning
- 27 July 1, 2012. Prior to that date, the bill's provisions would
- 28 apply on a voluntary basis on the part of school districts and
- 29 state agencies.
- 30 The bill defines a "state building" as a public facility
- 31 or building owned or leased by the state, or an agency or
- 32 department of the state. The bill provides that a school
- 33 district or a state agency procuring supplies for a school
- 34 or state building may deplete its existing cleaning and
- 35 maintenance supply stocks and implement the new requirements

- 1 in the procurement cycle for the following year, and shall
- 2 be exempt from compliance if the school district or state
- 3 agency submits written documentation to the department of
- 4 public health on an annual basis that adoption of the policy
- 5 would result in a significant increase in annual cleaning and
- 6 maintenance product and supply costs.
- 7 The bill provides that the department shall establish by
- 8 rule and update a policy of guidelines and specifications for
- 9 the use of environmentally preferable cleaning products. The
- 10 department is instructed to provide multiple avenues by which
- 11 cleaning products may be determined to be environmentally
- 12 preferable, to include in the guidelines implementation
- 13 practices and inspection procedures, and to post on the
- 14 department's internet website and distribute to each school
- 15 updated copies of the policy.
- 16 The bill may include a state mandate as defined in Code
- 17 section 25B.3. The bill requires, with respect to public
- 18 school districts, that the state cost of any state mandate
- 19 included in the bill be paid by a school district from state
- 20 school foundation aid received by the district under Code
- 21 section 257.16. This specification is deemed to constitute
- 22 state compliance with any state mandate funding-related
- 23 requirements of Code section 25B.2. The inclusion of this
- 24 specification is intended to reinstate the requirement of
- 25 political subdivisions to comply with any state mandates
- 26 included in the bill.
