(SUCCESSOR TO SSB 3205)

A BILL FOR

1 An Act relating to the regulation of motor vehicles by the
2 department of transportation, including clarification of
3 the definition of business-trade truck and requirements for
4 the issuance of temporary persons with disabilities parking
5 permits.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 321.1, subsection 7A, Code Supplement
2 2009, is amended to read as follows:

3 7A. "*Business-trade truck*" means a model year 2010 or
4 newer motor truck with an unladen weight of ten thousand pounds
5 or less which is owned by a corporation, limited liability
6 company, or partnership or by a person who files a schedule C
7 or schedule F form with the federal internal revenue service
8 and which is eligible for depreciation under § 167 of the
9 Internal Revenue Code. If the motor truck is a leased vehicle,
10 the motor truck is a business-trade truck only if the lessee
11 is a corporation, limited liability company, or partnership
12 and the truck is used primarily for purposes of the business
13 operations of the corporation, limited liability company, or
14 partnership or the lessee is a person who files a schedule C or
15 schedule F form with the federal internal revenue service and
16 the truck is used primarily for purposes of the person's own
17 business or farming operation.

18 Sec. 2. Section 321L.2, subsection 1, unnumbered paragraph
19 1, Code Supplement 2009, is amended to read as follows:

20 A resident of the state with a disability desiring a persons
21 with disabilities parking permit shall apply to the department
22 upon an application form furnished by the department providing
23 the applicant's full legal name, address, date of birth, and
24 social security number or Iowa driver's license number or
25 Iowa nonoperator's identification card number, and shall also
26 provide a statement from a physician licensed under chapter
27 148 or 149, a physician assistant licensed under chapter
28 148C, an advanced registered nurse practitioner licensed
29 under chapter 152, or a chiropractor licensed under chapter
30 151, or a physician, physician assistant, nurse practitioner,
31 or chiropractor licensed to practice in a contiguous state,
32 written on the physician's, physician assistant's, nurse
33 practitioner's, or chiropractor's stationery, stating the
34 nature of the applicant's disability and such additional
35 information as required by rules adopted by the department

1 under section 321L.8. If the person is applying for a
2 temporary persons with disabilities parking permit, the
3 physician's, physician assistant's, nurse practitioner's, or
4 chiropractor's statement shall state the period of time during
5 which the person is expected to be disabled and the period
6 of time for which the permit should be issued, not to exceed
7 six months. The department may waive the requirement that
8 the applicant furnish the applicant's social security number,
9 Iowa driver's license number, or nonoperator's identification
10 card number when the application for a temporary persons with
11 disabilities parking permit is made on behalf of a person who
12 is less than one year old.

13 EXPLANATION

14 This bill amends the definition of "business-trade truck"
15 to clarify that the term applies only to model year 2010 or
16 newer motor trucks. For purposes of motor vehicle registration
17 fees, a "business-trade truck" is a motor truck with an unladen
18 weight of 10,000 pounds or less which is used for business or
19 farming.

20 The bill allows the department of transportation to
21 waive the requirement that an applicant for a persons with
22 disabilities parking permit furnish the applicant's social
23 security number, driver's license number, or nonoperator's
24 identification card number when the application is for a
25 temporary permit and is made on behalf of a person who is less
26 than one year old.
