## A BILL FOR

- 1 An Act providing notification to the department of workforce
- development by the secretary of state when certain business
- 3 entities apply for reinstatement after dissolution to ensure
- 4 certain tax obligations have been fulfilled.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 489.706, subsection 2, Code 2009, is 2 amended to read as follows:
- 3 2. The secretary of state shall refer the federal tax
- 4 identification number contained in the application for
- 5 reinstatement to the department departments of revenue and
- 6 workforce development. The department departments of revenue
- 7 and workforce development shall report to the secretary of
- 8 state the tax status of the limited liability company. If
- 9 the either department reports to the secretary of state that
- 10 a filing delinquency or liability exists against the limited
- 11 liability company, the secretary of state shall not cancel the
- 12 declaration of dissolution until the filing delinquency or
- 13 liability is satisfied.

- 15 the secretary of state shall not cancel the certificate of
- 16 dissolution until the filing delinquency or liability is

- 18 Sec. 5. Section 504.1423, subsection 2, paragraph a, Code
- 19 2009, is amended to read as follows:
- 20 a. The secretary of state shall refer the federal tax
- 21 identification number contained in the application for
- 22 reinstatement to the department departments of revenue
- 23 and workforce development. The department departments of
- 24 revenue and workforce development shall report to the
- 25 secretary of state the tax status of the corporation. If
- 26 the either department reports to the secretary of state that a
- 27 filing delinquency or liability exists against the corporation,
- 28 the secretary of state shall not cancel the certificate of
- 29 dissolution until the filing delinquency or liability is

- 31 EXPLANATION
- 32 This bill directs the secretary of state to notify the
- 33 department of workforce development when a limited liability
- 34 company, corporation, cooperative, or nonprofit corporation
- 35 applies for reinstatement after a dissolution. The department

- 1 must report the tax status to the secretary of state, including
- 2 any filing delinquencies or liabilities, which would include
- 3 unpaid unemployment insurance tax. Any filing delinquencies or
- 4 liabilities would prevent the secretary of state from canceling
- 5 the business entity's certificate of dissolution until the
- 6 matter is resolved.
