- 1 An Act relating to the abuse of a corpse and providing

- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 229A.2, subsection 10, paragraph a, Code
- 2 2009, is amended to read as follows:
- a. A violation of any provision of chapter 709, except
- 4 section 709.18, subsection 2 or 3.
- 5 Sec. 2. Section 692A.102, subsection 1, paragraph b,
- 6 Code Supplement 2009, is amended by adding the following new
- 7 subparagraph:
- 8 NEW SUBPARAGRAPH. (130) Sexual abuse of a corpse in
- 9 violation of section 709.18.
- 10 Sec. 3. NEW SECTION. 708.14 Abuse of a corpse.
- 11 1. A person commits abuse of a human corpse if the person
- 12 does any of the following:
- 13 a. Mutilates, disfigures, or dismembers a human corpse with
- 14 the intent to conceal a crime.
- 15 b. Hides or buries a human corpse with the intent to conceal
- 16 a crime.
- 2. A person who violates this section commits a class "D"
- 18 felony.
- 19 Sec. 4. Section 709.18, Code 2009, is amended to read as
- 20 follows:
- 21 709.18 Abuse Sexual abuse of a corpse.
- 22 l. A person commits sexual abuse of a human corpse if the
- 23 person knowingly and intentionally engages in a sex act, as
- 24 defined in section 702.17, with a human corpse.
- 25 2. A person commits abuse of a human corpse if the person
- 26 mutilates, disfigures, or dismembers a human corpse with the
- 27 intent to conceal a crime.
- 28 3. A person commits abuse of a human corpse if the person
- 29 hides or buries a human corpse with the intent to conceal a
- 30 crime.
- 31 4. 2. A person who violates this section commits a class
- 32 "D" felony.
- 33 EXPLANATION
- 34 This bill relates to the criminal offense of abuse of a
- 35 corpse.

S.F. H.F.

- 1 The bill transfers some "abuse of a corpse" provisions from
- 2 Code section 709.18 to Code chapter 708 (assault) and creates
- 3 new Code section 708.14. The bill renames the "abuse of a
- 4 corpse" offense remaining in Code section 709.18 as "sexual
- 5 abuse of a corpse".
- 6 The bill requires a person who commits sexual abuse of
- 7 a corpse to register as a tier II sex offender. A tier II
- 8 offender must verify the offender's relevant information with
- 9 the county sheriff of the principal place of residence every
- 10 six months.
- 11 The bill does not modify the penalty classification for the
- 12 criminal offense that remains in Code section 709.18 or for the
- 13 criminal offenses transferred to new Code section 708.14. A
- 14 person who commits a violation of the bill commits a class "D"
- 15 felony.
- 16 The bill does effect the criminal penalties applicable to
- 17 the criminal offenses transferred to new Code section 708.14.
- 18 Under the bill, as a result of transferring the criminal
- 19 offenses to new Code section 708.14, these transferred offenses
- 20 are no longer sexual offenses under Code chapter 709 and
- 21 therefore not subject to a special sentence pursuant to Code
- 22 section 903B.2.
