A BILL FOR

- 1 An Act relating to escapes or attempted escapes from custody
- 2 due to the commission of a criminal offense and providing a
- 3 penalty.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 719.4, Code 2009, is amended to read as 2 follows:
- 3 719.4 Escape or absence from custody.
- A person convicted of a felony criminal offense,
- 5 or charged with or arrested for the commission of a
- 6 felony criminal offense, who intentionally escapes, or
- 7 attempts to escape, from a detention facility, community-based
- 8 correctional facility, or institution to which the person has
- 9 been committed by reason of the conviction, charge, or arrest,
- 10 or from the custody of any public officer, public employee, or
- 11 any other person to whom the person has been entrusted, commits
- 12 a class "D" felony.
- 2. A person convicted of, charged with, or arrested for
- 14 a misdemeanor, who intentionally escapes, or attempts to
- 15 escape, from a detention facility, community-based correctional
- 16 facility, or institution to which the person has been committed
- 17 by reason of the conviction, charge, or arrest, or from the
- 18 custody of any public officer, public employee, or any other
- 19 person to whom the person has been entrusted, commits a serious
- 20 misdemeanor.
- 21 3. 2. A person who has been committed to an institution
- 22 under the control of the Iowa department of corrections, to
- 23 a community-based correctional facility, or to a jail or
- 24 correctional institution, who knowingly and voluntarily is
- 25 absent from a place where the person is required to be, commits
- 26 a serious misdemeanor.
- 27 4. 3. A person who flees from the state to avoid
- 28 prosecution for a public offense which is a felony or
- 29 aggravated misdemeanor commits a class "D" felony.
- 30 5. 4. Except for subsection 4 3, an offense committed under
- 31 this section includes any offense committed wholly outside the
- 32 state.
- 33 EXPLANATION
- 34 This bill relates to escapes from custody. The bill
- 35 equalizes the criminal penalty for all escapes or attempted

- 1 escapes from custody.
- 2 Under the bill, a person convicted, charged, or arrested
- 3 for the commission of any criminal offense, who intentionally
- 4 escapes, or attempts to escape from a detention facility,
- 5 community-based correctional facility, or institution, or
- 6 escapes or attempts to escape from the custody of any public
- 7 officer, public employee, or any other person who has custody,
- 8 commits a class "D" felony.
- 9 Current law provides that a person commits a class "D" felony
- 10 for an escape or attempted escape if the underlying criminal
- 11 offense which leads to the custody of the person is a felony,
- 12 and if the underlying criminal offense which leads to the
- 13 custody of the person is a misdemeanor, the person commits a
- 14 serious misdemeanor.
- 15 A serious misdemeanor is punishable by confinement for no
- 16 more than one year and a fine of at least \$315 but not more than
- 17 \$1,875. A class "D" felony is punishable by confinement for no
- 18 more than five years and a fine of at least \$750 but not more
- 19 than \$7,500.
