- 1 An Act relating to permits issued under the national pollutant

2	PERSONS CONTESTING THE DENIAL
3	OF APPLICATIONS OR PERMITS ISSUED UNDER NPDES
4	Section 1. Section 455B.174, subsection 4, paragraph b,
5	Code Supplement 2009, is amended to read as follows:
6	b. In addition to the requirements of paragraph " a ", a
7	permit shall not be issued to operate or discharge from any
8	disposal system unless the conditions of the permit assure
9	that any discharge from the disposal system meets or will
L 0	meet all applicable state and federal water quality standards
L1	and effluent standards and the issuance of the permit is not
L 2	otherwise prohibited by the federal Water Pollution Control
L3	Act. All applications for discharge permits are subject
L 4	to public notice and opportunity for public participation

L 6	The director shall promptly notify the applicant in writing
L7	of the director's action and, if the permit is denied, state

- 2 feeding operation as defined in 40 C.F.R. § 122.23(b) shall
- 3 comply with applicable national pollutant discharge elimination
- 4 system permit requirements as provided in the federal Water
- 5 Pollution Control Act, 33 U.S.C. ch. 26, as amended, and 40
- 6 C.F.R. pts. 122 and 412, pursuant to rules that shall be

- 11 EXPLANATION
- 12 DIVISION I PERSONS CONTESTING THE DENIAL OF APPLICATIONS
- 13 OR PERMITS ISSUED UNDER NPDES. This division provides for
- 14 water pollution control permits issued under the federal
- 15 national pollutant discharge elimination system (NPDES). Code
- 16 section 455B.174 provides that a person who has been denied
- 17 an NPDES permit or who has been issued an NPDES permit by the
- 18 director of the department of natural resources may appeal the
- 19 director's decision to the environmental protection commission.
- 20 The commission's decision is the agency's final decision (or
- 21 final agency action) under the Iowa administrative procedure
- 22 Act (Code chapter 17A), meaning that the person may appeal the
- 23 decision to district court under Code section 17A.19. This
- 24 bill provides a substitute procedure. In lieu of a commission
- 25 hearing, the person may initiate a contested case proceeding
- 26 under Code chapter 17A which must be heard by an administrative
- 27 law judge (ALJ).
- 28 DIVISION II NPDES PERMITS ISSUED TO CONFINEMENT FEEDING
- 29 OPERATIONS. This division amends Code chapter 459, the
- 30 animal agriculture compliance Act (Code section 459.101).
- 31 Generally, a confinement feeding operation is prohibited from
- 32 discharging manure directly into water of the state or into
- 33 a tile line that discharges directly into water of the state
- 34 (Code section 459.311). This bill provides that a confinement
- 35 feeding operation that is classified as a concentrated animal

- 1 feeding operation under the NPDES must comply with applicable
- 2 NPDES permit requirements pursuant to rules adopted by the
- 3 environmental protection commission. The rules cannot be more
- 4 stringent than federal law.
- 5 A person who violates a provision in Code chapter 459
- 6 relating to water quality is subject to penalties as provided
- 7 in Code section 455B.109 or 455B.191 (see Code section
- 8 459.603). A person in violation of a requirement may be
- 9 assessed a civil penalty by the commission, according to a
- 10 schedule, not to exceed \$10,000 or may be assessed a judicially
- 11 assessed civil penalty of up to \$5,000 per each day of the
- 12 violation.
