- 1 An Act creating a natural resources and outdoor recreation
- 2 trust fund to implement a proposed amendment to the
- 3 Constitution of the State of Iowa, and providing for
- 4 contingent implementation.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 SUBCHAPTER I

- 2 GENERAL PROVISIONS
- 3 Section 1. NEW SECTION. 461.1 Title.
- 4 This Act shall be known and may be cited as the natural
- 5 resources and outdoor recreation Act.
- 6 Sec. 2. NEW SECTION. 461.2 Definitions.
- 7 As used in this chapter, unless the context otherwise
- 8 requires:
- 9 1. "Department" means the department of agriculture and
- 10 land stewardship, the department of natural resources, or the
- 11 department of transportation.
- 12 2. "Fiscal year" means the state fiscal year effective as
- 13 provided in section 3.12.
- 3. "Initiative" includes a program, project, practice,
- 15 strategy, or plan established or administered by an agency that
- 16 furthers a constitutional purpose as provided in section 461.3.
- 17 4. "Recreational purpose" includes hunting, trapping,
- 18 angling, horseback riding, swimming, boating, camping,
- 19 picnicking, hiking, bird watching, nature study, water skiing,
- 20 snowmobiling, other summer and winter sports, and viewing or
- 21 enjoying historical, archaeological, scenic, or scientific
- 22 sites.
- 23 5. "Trust fund" means the natural resources and outdoor
- 24 recreation trust fund created in section 461.3.
- 25 6. "Trust fund moneys" means moneys originating from the
- 26 natural resources and outdoor recreation trust fund.
- 27 Sec. 3. NEW SECTION. 461.3 Constitutional purpose and
- 28 implementation.
- 29 1. This chapter is created for the constitutional purposes
- 30 of protecting and enhancing water quality and natural areas
- 31 in this state including parks, trails, and fish and wildlife
- 32 habitat, and conserving agricultural soils in this state.
- This chapter is intended to implement Article VII,
- 34 section 10 of the Constitution of the State of Iowa by
- 35 establishing the natural resources and outdoor recreation

- 1 trust fund, accounts in the trust fund, and appropriating or
- 2 allocating trust fund moneys to support initiatives specified
- 3 in subchapter IV.
- 4 SUBCHAPTER II
- 5 PARTICIPATION
- 6 Sec. 4. NEW SECTION. 461.11 Departmental consultation.
- 7 l. When making decisions regarding the expenditure of
- 8 trust fund moneys affecting soil and water conservation, the
- 9 secretary of agriculture shall regularly consult with the
- 10 soil conservation committee established in section 161A.4.
- 11 When making decisions regarding the expenditure of trust fund
- 12 moneys affecting natural resources and outdoor recreation the
- 13 director of the department of natural resources shall regularly
- 14 consult with the natural resource commission established
- 15 pursuant to section 455A.5. When making decisions regarding
- 16 the expenditure of trust fund moneys affecting trails, the
- 17 department of transportation shall consult with the state
- 18 transportation commission as provided in chapter 307A.
- 19 2. The heads of each department receiving trust fund moneys
- 20 shall regularly meet and whenever practicable collaborate in
- 21 decision-making including by adopting rules, establishing
- 22 funding priorities, and determining when it is beneficial to
- 23 provide joint funding of initiatives.
- 24 SUBCHAPTER III
- 25 ADMINISTRATION
- 26 Sec. 5. NEW SECTION. 461.21 Audit.
- 27 l. The treasurer of state shall certify monthly that trust
- 28 fund moneys are allocated to the various funds and accounts as
- 29 provided in subchapter IV.
- 30 2. The auditor of state or a certified public accounting
- 31 firm appointed by the auditor of state shall conduct an annual
- 32 audit of the trust fund and all accounts and transactions of
- 33 the trust fund and accounts.
- 34 3. The auditor of state or the certified public accounting
- 35 firm appointed by the auditor as provided in subsection 2 shall

- 1 be paid from trust fund moneys without reducing the percentage
- 2 of trust fund moneys distributed to any one account established
- 3 pursuant to this chapter.
- 4 Sec. 6. NEW SECTION. 461.22 Report.
- 5 The three departments together with the treasurer of state
- 6 and the auditor of state shall jointly prepare and submit to
- 7 the governor and the general assembly not later than January
- 8 15 of each year a complete report in an electronic format
- 9 detailing all of the following:
- 10 l. A description of public hearings and meetings required
- 11 to be conducted pursuant to subchapter II, any results that
- 12 impacted upon departmental decision-making, and a plan for
- 13 conducting public hearings and meetings in the following year.
- 2. The receipts and expenditures of the trust fund and its
- 15 accounts, a summary of initiatives supported by trust fund
- 16 moneys, the results of those expenditures, any performance
- 17 goals or measurements, and plans for future short-term or
- 18 long-term expenditures.
- 19 3. Recommendations to the general assembly, including
- 20 legislation proposed by one or more of the departments.
- 21 Sec. 7. NEW SECTION. 461.23 Rules.
- 22 The treasurer of state, the auditor of state, the
- 23 department of revenue, and the department of agriculture and
- 24 land stewardship, the department of natural resources, and
- 25 department of transportation shall adopt rules separately or
- 26 jointly as necessary in order to implement and administer this
- 27 chapter.
- 28 SUBCHAPTER IV
- 29 NATURAL RESOURCES AND OUTDOOR RECREATION TRUST FUND
- 30 AND DISTRIBUTIONS TO SUPPORT DEDICATED PURPOSES
- 31 Sec. 8. NEW SECTION. 461.31 Natural resources and outdoor
- 32 recreation trust fund creation.
- 33 A natural resources and outdoor recreation trust fund is
- 34 created within the state treasury.
- 35 l. The trust fund shall be composed of moneys required to

- 1 be credited to the trust fund by law and moneys accepted by
- 2 a department for placement in an account established in this
- 3 subchapter and from any source.
- 4 2. Trust fund moneys are exclusively appropriated by law
- ${\bf 5}$ to carry out the constitutional purposes provided in section
- 6 461.3.
- 7 3. Trust fund moneys shall supplement and not replace
- 8 moneys appropriated by the general assembly to support the
- 9 constitutional purposes provided in section 461.3.
- 10 4. Trust fund moneys shall only be used to support voluntary
- 11 initiatives and shall not be used for regulatory efforts,
- 12 enforcement actions, or litigation.
- 13 5. In administering a trust fund account, a department
- 14 may contract, sue and be sued, and authorize payment for
- 15 costs, fees, commissions, and other reasonable expenses from
- 16 the account. However, a department shall not in any manner
- 17 directly or indirectly pledge the credit of this state.
- 18 6. Notwithstanding section 8.33, any unexpended balance in
- 19 the trust fund or in an account created within the trust fund
- 20 at the end of each fiscal year shall be retained in the trust
- 21 fund or the respective account. Notwithstanding section 12C.7,
- 22 subsection 2, interest or earnings on investments or time
- 23 deposits of the moneys in the trust fund and its respective
- 24 accounts shall be credited to the trust fund and its respective
- 25 accounts. The recapture of awards originating from an account
- 26 and other repayments to an account shall be retained in that
- 27 account.
- 28 Sec. 9. NEW SECTION. 461.32 Outdoor recreation account
- 29 allocations.
- 30 An outdoor recreation account is created in the trust fund.
- 31 Twenty-three percent of the moneys credited to the trust fund
- 32 shall be allocated to the account.
- 33 1. The account shall be used by the department of natural
- 34 resources to support all of the following initiatives:
- 35 a. The maintenance and improvement of state parks, state

- 1 preserves, wildlife areas, wildlife habitats, native prairies,
- 2 and wetlands.
- 3 b. Wildlife diversity.
- 4 c. Recreational purposes.
- 5 d. Technical assistance and financial incentives to private
- 6 landowners to promote the management of forests, fisheries,
- 7 wetlands, and wildlife.
- 8 e. The improvement of water trails, rivers, and streams.
- 9 f. Education and outreach that provide instruction regarding
- 10 natural history and the outdoors. The subjects of such
- 11 instruction may relate to opportunities involving recreational
- 12 purposes, outdoor safety, and ethics.
- 13 g. State conservation law enforcement.
- 2. The department of natural resources shall to every extent
- 15 possible consider its comprehensive plan provided in section
- 16 456A.31 when making funding decisions.
- 3. The department of natural resources may allocate trust
- 18 fund moneys to the state fish and game protection fund, the
- 19 state conservation fund, or the county conservation board fund,
- 20 all as created in section 456A.17, or the forestry management
- 21 and enhancement fund created in section 456A.21.
- 22 Sec. 10. NEW SECTION. 461.33 Soil conservation and water
- 23 protection account allocations.
- 24 A soil conservation and water protection account is created
- 25 in the trust fund. Twenty percent of the moneys credited to
- 26 the trust fund shall be allocated to the account.
- 27 1. The account shall be used by the department of
- 28 agriculture and land stewardship to support all of the
- 29 following initiatives:
- 30 a. Soil conservation and watershed protection, including
- 31 by supporting the soil conservation division of the department
- 32 of agriculture and land stewardship and soil and water
- 33 conservation district commissioners. The department may
- 34 provide for the installation of conservation practices and
- 35 watershed protection improvements as provided in chapters 161A,

- 1 161C, 461A, 466, and 466A.
- 2 b. The conservation of highly erodible land. The department
- 3 of agriculture and land stewardship may execute contracts with
- 4 private landowners who agree to reserve such land only for uses
- 5 that prevent erosion in excess of the applicable soil loss
- 6 limits as established in section 161A.44.
- 7 c. Soil conservation or crop management practices used
- 8 on land producing biomass as a feedstock for biorefineries,
- 9 including cellulosic ethanol production.
- 10 2. The department of agriculture and land stewardship may
- 11 use the account to provide financial incentives or technical
- 12 assistance to landowners.
- 3. The department of agriculture and land stewardship
- 14 may allocate trust fund moneys to the conservation practices
- 15 revolving loan fund established in section 161A.71, the
- 16 blufflands protection program and revolving fund created in
- 17 section 161A.80, the Loess hills development and conservation
- 18 fund created in section 161D.2, the southern Iowa development
- 19 and conservation fund created in section 161D.12, and the
- 20 agricultural drainage well water quality assistance fund
- 21 created in section 460.303.
- 22 Sec. 11. NEW SECTION. 461.34 Watershed protection account
- 23 allocations.
- 24 A watershed protection account is created in the trust fund.
- 25 Fourteen percent of the moneys credited to the trust fund shall
- 26 be allocated to the account.
- 27 l. The account shall be used cooperatively by the department
- 28 of natural resources and the department of agriculture and land
- 29 stewardship to support all of the following initiatives:
- 30 a. Water resource projects administered by the department
- 31 of natural resources to preserve watersheds, including but not
- 32 limited to all of the following:
- 33 (1) Projects to protect, restore, or enhance water quality
- 34 in the state through the provision of financial assistance to
- 35 communities for impairment-based, locally directed watershed

- 1 projects. The department may use the account to support the
- 2 water resource restoration sponsor program as provided in
- 3 section 455B.199.
- 4 (2) Regional and community watershed assessment, planning,
- 5 and prioritization efforts, including as provided in chapter
- 6 466B.
- 7 b. Surface water protection projects and practices
- 8 administered by the department of agriculture and land
- 9 stewardship or the department of natural resources, including
- 10 but not limited to the installation of permanent vegetation
- 11 cover, filter strips, grass waterways, and riparian forest
- 12 buffers; dredging; and bank stabilization. The departments
- 13 of agriculture and land stewardship and natural resources
- 14 may use the account to support the conservation buffer strip
- 15 program provided in section 466.4 and the conservation reserve
- 16 enhancement program as provided in section 466.5.
- 2. The departments' decision to prioritize initiatives may
- 18 be based on the priority list of watersheds provided in section
- 19 456A.33A.
- 20 3. The department of agriculture and land stewardship may
- 21 allocate trust fund moneys to the water protection fund created
- 22 in section 161C.4, the organic nutrient management fund created
- 23 pursuant to section 161C.5, or the watershed improvement fund
- 24 created in section 466A.2.
- 25 Sec. 12. NEW SECTION. 461.35 Iowa resources enhancement and
- 26 protection fund allocation.
- 27 Thirteen percent of the moneys credited to the trust
- 28 fund shall be allocated to the Iowa resources enhancement
- 29 and protection fund created in section 455A.18 for further
- 30 allocation as provided in section 455A.19.
- 31 Sec. 13. NEW SECTION. 461.36 Local conservation partnership
- 32 account allocations.
- 33 A local conservation partnership account is created in the
- 34 trust fund. Thirteen percent of the moneys credited to the
- 35 trust fund shall be allocated to the account.

- 1 l. The department of natural resources shall allocate
- 2 trust fund moneys in the account to local communities for the
- 3 following initiatives:
- 4 a. The maintenance and improvement of parks, preserves,
- 5 wildlife areas, wildlife habitats, native prairies, and
- 6 wetlands.
- 7 b. Wildlife diversity.
- 8 c. Recreational purposes.
- 9 d. The improvement of water trails, rivers, and streams.
- 10 e. Education and outreach programs and projects that provide
- 11 instruction regarding natural history and the outdoors. The
- 12 subjects of such instruction may relate to opportunities
- 13 involving recreational purposes, outdoor safety, and ethics.
- 14 f. Any other purpose described in section 350.1.
- 2. A local community may cooperate with the state or the
- 16 federal government to carry out the initiative. Two or more
- 17 local communities may form an entity if allowed under chapter
- 18 28E in order to carry out the initiative.
- 19 3. As used in this section, "local community" means a county
- 20 conservation board, a city, or a nongovernmental organization
- 21 operating on a nonprofit basis.
- 22 Sec. 14. NEW SECTION. 461.37 Trails account allocations.
- 23 A trails account is created in the trust fund. Ten percent
- 24 of the moneys credited to the trust fund shall be allocated to
- 25 the account.
- 26 1. The department of transportation and the department
- 27 of natural resources shall allocate moneys in the account to
- 28 support initiatives related to the design, establishment,
- 29 maintenance, improvement, and expansion of land trails.
- 30 a. The land trails may be for equestrian use, bicycles,
- 31 walking, hiking, nature study, or cross-country skiing.
- 32 b. The departments may provide for trails on land in which
- 33 the department of transportation or the department of natural
- 34 resources has acquired rights as scenic easements as defined
- 35 in section 308.3.

- 1 2. The department of transportation may use the account
- 2 to support integrated roadside vegetation management planning
- 3 and projects as provided in section 314.22. The department of
- 4 transportation may deposit a portion of the trust fund moneys
- 5 in the living roadway trust fund as provided in section 314.21.
- 6 3. The department of natural resources may use the account
- 7 to support the design, establishment, maintenance, improvement,
- 8 and expansion of water trails. The department of natural
- 9 resources may use the account to implement the water trails
- 10 and low head dam public hazard statewide plan as provided in
- 11 section 464A.11.
- 12 Sec. 15. NEW SECTION. 461.38 Lake restoration account —
- 13 allocations.
- 14 A lake restoration account is created in the trust fund.
- 15 Seven percent of the moneys credited to the trust fund shall
- 16 be deposited to the account. The department of natural
- 17 resources shall use moneys in the account to support public
- 18 lake restoration initiatives as follows:
- An initiative shall account for a lake's recreational,
- 20 environmental, aesthetic, ecological, and social value. It
- 21 must improve water quality.
- 22 2. The department's decision to prioritize an initiative
- 23 may be based on the department's lake restoration plan and
- 24 report as provided in section 456A.33B.
- 25 Sec. 16. CONTINGENT IMPLEMENTATION. This Act shall be
- 26 implemented on January 1, 2011, if the joint resolution
- 27 proposing an amendment to the Constitution of the State of Iowa
- 28 to dedicate a portion of state revenue from the tax imposed on
- 29 certain retail sales of tangible personal property and services
- 30 for the benefit of the state's natural resources, as passed for
- 31 the second time by the general assembly as provided in 2009
- 32 Iowa Acts, chapter 185, and submitted to the people of the
- 33 State of Iowa at the general election in November 2010, in the
- 34 manner required by the Constitution of the State of Iowa and
- 35 the laws of this state, is ratified.

1 EXPLANATION

BACKGROUND. In 2008, the 82nd General Assembly passed 2 3 Senate Joint Resolution 2002 and in 2009 the 83rd General 4 Assembly passed House Joint Resolution 1 proposing an amendment 5 to the Constitution of the State of Iowa to dedicate a portion 6 of state revenue from the tax imposed on certain retail sales 7 of tangible personal property and services for the benefit 8 of the state's natural resources. The resolution creates a 9 natural resources and outdoor recreation trust fund within the 10 state treasury and not within the general fund of the state. 11 Moneys in the fund cannot be used for any purpose other than 12 protecting and enhancing water quality and natural areas in 13 this state including parks, trails, and fish and wildlife 14 habitat, and conserving agricultural soils in this state. 15 revenue is credited to the fund until the sales and use tax 16 rate is increased. Whenever the sales tax is increased, the 17 amount generated by the increase is credited to the fund. 18 approved by a majority of Iowa voters, the constitution of 19 the state is amended effective as of the date of the general

- 20 election. 21 The bill creates a new Code chapter referred to GENERAL. 22 as the natural resources and outdoor recreation Act. The bill 23 provides that its purpose is to implement the constitutional 24 purposes of protecting and enhancing water quality and natural 25 areas in this state including parks, trails, and fish and 26 wildlife habitat, and conserving agricultural soils in this 27 state. The fund is administered by the treasurer of state 28 and provides for distributions to support various initiatives 29 to be carried out by the department of natural resources, 30 the department of agriculture and land stewardship, and the 31 state department of transportation. An initiative includes 32 a program, project, practice, strategy, or plan established 33 or administered by an agency that furthers a constitutional
- 35 PARTICIPATION. The bill requires the heads of the three

34 purpose as provided in Code section 461.3.

- 1 departments who make decisions regarding the expenditure
- 2 of trust fund moneys to consult with bodies that oversee
- 3 policies concerned with natural resources. The director of
- 4 the department of natural resources must consult with the
- 5 natural resource commission, the secretary of agriculture must
- 6 consult with the state soil conservation committee, and the
- 7 director of the department of transportation must consult with
- 8 the state transportation commission. The heads of the three
- 9 departments must regularly meet together and collaborate when
- 10 making decisions.
- 11 ADMINISTRATION. The bill requires annual audits by the
- 12 auditor of state or a private accounting firm. Finally, the
- 13 three departments together with the treasurer of state and
- 14 auditor of state must submit an annual report to the governor
- 15 detailing the management of the trust fund, decision-making,
- 16 and the results of expenditures from the trust fund. The bill
- 17 requires those agencies to adopt rules necessary to carry out
- 18 their responsibilities.
- 19 TRUST FUND ESTABLISHED. The bill creates the trust
- 20 fund, provides that moneys may be credited to the fund as
- 21 provided by law or accepted by a decision-making department
- 22 for placement in an account under its control. According to
- 23 the bill, trust fund moneys shall supplement and not replace
- 24 moneys appropriated by the general assembly to support the
- 25 constitutional purposes, must be used to support voluntary
- 26 initiatives, and shall not be used for regulatory efforts,
- 27 enforcement actions, or litigation. Moneys in a fund or
- 28 account remain in the fund or account until expended and retain
- 29 all earnings.
- 30 TRUST FUND ALLOCATIONS OUTDOOR RECREATION ACCOUNT. The
- 31 bill creates an outdoor recreation account and provides for the
- 32 allocation of trust fund moneys to the account for use by the
- 33 department of natural resources to support initiatives related
- 34 to state lands, wildlife, recreation, natural habitat, rivers
- 35 and streams, education, and state conservation law enforcement.

- 1 The department is authorized to deposit trust fund moneys into
- 2 a number of secondary funds, including the state fish and game
- 3 protection fund, the state conservation fund, or the county
- 4 conservation fund.
- 5 SOIL CONSERVATION AND WATER PROTECTION ACCOUNT. The bill
- 6 creates a soil conservation and water protection account and
- 7 provides for the allocation of trust fund moneys into the
- 8 account for use by the department of agriculture and land
- 9 stewardship to support initiatives related to soil conservation
- 10 and watershed protection to support the department's soil
- 11 conservation division and soil and water conservation
- 12 district commissioners. The department may also provide for
- 13 the conservation of highly erodible land and provide for
- 14 soil conservation or crop management practices used on land
- 15 producing biomass as a feedstock for biorefineries. The
- 16 department may allocate trust fund moneys to the conservation
- 17 practices revolving loan fund, the blufflands protection
- 18 program and revolving fund, the Loess hills development
- 19 and conservation fund, the southern Iowa development and
- 20 conservation fund, and the agricultural drainage well water
- 21 quality assistance fund.
- 22 WATERSHED PROTECTION ACCOUNT. The bill creates a watershed
- 23 protection account and provides for the allocation of trust
- 24 fund moneys into the account for use by the department of
- 25 natural resources and the department of agriculture and land
- 26 stewardship to support initiatives related to water resource
- 27 initiatives, including for the protection, restoration, or
- 28 enhancement of water quality in the state, and the installation
- 29 of vegetation as soil or pollution barriers. The department of
- 30 agriculture and land stewardship may allocate trust fund moneys
- 31 in the water protection fund, the organic nutrient management
- 32 fund, or the watershed improvement fund.
- 33 IOWA RESOURCES ENHANCEMENT AND PROTECTION FUND. The bill
- 34 provides for the allocation of trust fund moneys to the Iowa
- 35 resources enhancement and protection fund for allocations as

1 provided by law.

- 2 LOCAL CONSERVATION PARTNERSHIP ACCOUNT. The bill creates
- 3 a local conservation partnership account and provides for
- 4 the allocation of trust fund moneys into the account for use
- 5 by the department of natural resources to support community
- 6 initiatives, including for parks, preserves, wildlife areas,
- 7 wildlife habitats, native prairies, and wetlands; wildlife
- 8 diversity; recreation; the improvement of water trails, rivers,
- 9 and streams; and education and outreach. A local community
- 10 is limited to a county conservation board, a city, or a
- 11 nongovernmental organization operating on a nonprofit basis; or
- 12 a city or county allowed to organize under a Code chapter 28E
- 13 agreement.
- 14 TRAILS ACCOUNT. The bill creates a trails account and
- 15 provides for the allocation of trust fund moneys into the
- 16 account for use by the department of transportation and
- 17 the department of natural resources to support the design,
- 18 establishment, maintenance, improvement, and expansion of land
- 19 trails and water trails. The department of transportation
- 20 may use the account to support integrated roadside vegetation
- 21 management planning and projects and it may allocate a portion
- 22 of the trust fund moneys to the living roadway trust fund. The
- 23 department of natural resources may use the trust fund moneys
- 24 to implement the water trails and low head dam public hazard
- 25 statewide plan.
- 26 LAKE RESTORATION ACCOUNT. The bill creates a lake
- 27 restoration account and provides for the allocation of trust
- 28 fund moneys into the account for use by the department of
- 29 natural resources to support initiatives related to lake
- 30 restoration taking into account a lake's recreational,
- 31 environmental, aesthetic, ecological, and social value.
- 32 CONTINGENT IMPLEMENTATION. The bill is to be implemented
- 33 on January 1, 2011, if the joint resolution proposing the
- 34 amendment to the Constitution of the State of Iowa is ratified.
