A BILL FOR

- 1 An Act relating to electrical and mechanical amusement devices
- 2 concerning liability for device distributors and penalties
- 3 for awarding cash prizes for the use of electrical or
- 4 mechanical amusement devices.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 99B.10, Code 2011, is amended by adding
- 2 the following new subsection:
- NEW SUBSECTION. 5. Notwithstanding any provision of this
- 4 section to the contrary, a distributor shall not be liable
- 5 for a violation of this section unless the distributor, or an
- 6 employee of the distributor, intentionally violates a provision
- 7 of this section.
- 8 Sec. 2. Section 99B.10B, subsection 2, Code 2011, is amended
- 9 to read as follows:
- 10 2. a. The department shall revoke a registration issued
- 11 pursuant to section 99B.10 or 99B.10A, for a period of ten
- 12 years if a person commits an offense of awarding a cash prize
- 13 in violation of section 99B.10, subsection 1, paragraph "b",
- 14 pursuant to rules adopted by the department. A person who
- 15 commits an offense of awarding a cash prize of twenty-five
- 16 dollars or less in violation of section 99B.10, subsection 1,
- 17 paragraph b'', pursuant to rules adopted by the department,
- 18 shall be issued a warning letter by the department.
- 19 b. A person who commits, within two years, a second offense
- 20 of awarding a cash prize of twenty-five dollars or less in
- 21 violation of section 99B.10, subsection 1, paragraph "b", or
- 22 a person who commits an offense of awarding a cash prize of
- 23 more than twenty-five dollars in violation of section 99B.10,
- 24 subsection 1, paragraph "b", pursuant to rules adopted by the
- 25 department, shall be subject to revocation of the person's
- 26 registration and the following:
- 27 (1) If the person whose registration is revoked under this
- 28 subsection who paragraph "b", is a person for which a class "A",
- 29 class "B", class "C", special class "C", or class "D" liquor
- 30 control license has been issued pursuant to chapter 123, shall
- 31 have the person's liquor control license shall be suspended for
- 32 a period of fourteen days in the same manner as provided in
- 33 section 123.50, subsection 3, paragraph "a". A
- 34 (2) If the person whose registration is revoked under this
- 35 subsection who paragraph "b", is a person for which only a

- 6 $\frac{b}{c}$ (3) If a person owning or employed by an establishment

- 8 or class "D" liquor control license issued pursuant to chapter
- 9 123 commits an offense of awarding a cash prize in violation of
- 10 section 99B.10, subsection 1, paragraph "b", pursuant to rules
- 11 adopted by the department as provided in this paragraph "b", the
- 12 liquor control license of the establishment shall be suspended
- 13 for a period of fourteen days in the same manner as provided in
- 14 section 123.50, subsection 3, paragraph "a".
- 15 (4) If a person owning or employed by an establishment
- 16 having a class "B" or class "C" beer permit issued pursuant to
- 17 chapter 123 awards a cash prize in violation of section 99B.10,
- 18 subsection 1, paragraph "b", pursuant to rules adopted by the
- 19 department commits an offense as provided in this paragraph
- 20 "b", the beer permit of the establishment shall be suspended
- 21 for a period of fourteen days in the same manner as provided in
- 22 section 123.50, subsection 3, paragraph "a".
- 23 EXPLANATION
- 24 This bill concerns electrical and mechanical amusement
- 25 devices.
- 26 Code section 99B.10 is amended to provide that a distributor
- 27 of a device shall not be liable for a violation of this Code
- 28 section relative to amusement devices unless the distributor
- 29 or an employee of the distributor intentionally violates the
- 30 Code section.
- 31 This bill also concerns the penalties applicable to a
- 32 person who awards a cash prize for the use of an electrical
- 33 or mechanical amusement device in violation of Code section
- 34 99B.10(1)(b). The bill provides that if the cash prize awarded
- 35 in violation of this provision is \$25 or less, the penalty

- 1 shall be a warning letter. Current penalties applicable to any
- 2 awarding of a cash prize in violation of this provision are
- 3 amended by the bill and made applicable to a second violation
- 4 of awarding a cash prize of \$25 or less within two years or to
- 5 a violation of awarding a cash prize of more than \$25. The
- 6 bill eliminates the 10-year revocation of the registration
- 7 authorizing an electrical or mechanical amusement device
- 8 penalty but retains the 14-day suspension of an applicable
- 9 liquor control license or beer permit penalty for a violation
- 10 of these provisions.
