A BILL FOR

- 1 An Act relating to requests for agency action involving rules
- 2 affecting livestock production, and including effective date
- 3 provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 17A.7, Code 2011, is amended by adding
- 2 the following new subsection:
- 3 NEW SUBSECTION. 3. To the extent that a provision in this
- 4 section conflicts with a provision in section 17A.7A, the
- 5 provision in section 17A.7A prevails.
- 6 Sec. 2. NEW SECTION. 17A.7A Petition for adoption of rules
- 7 and request for review of rules livestock production.
- 8 1. As used in this section, "regulatory burden" includes
- 9 but is not limited to an issue affecting the health, treatment,
- 10 or use of livestock; a condition or activity occurring on land
- ll used for the production of livestock, including but not limited
- 12 to the breeding, care, feeding, or housing of livestock; manure
- 13 management; or the disposal of a livestock carcass.
- 2. This section applies to a request for an agency action
- 15 submitted pursuant to section 17A.7, relating to the regulatory
- 16 burden placed upon a livestock producer, including a petition
- 17 to an agency requesting the adoption, amendment, or repeal
- 18 of a rule or a written request to the administrative rules
- 19 coordinator for an agency to conduct a formal review of a rule
- 20 of that agency. The administrative rules coordinator may
- 21 submit a request made under this section to the agency for a
- 22 decision.
- 23 3. The request shall be denied within the time period set
- 24 out in section 17A.7, if all of the following apply:
- 25 a. It is more likely than not that any action to adopt,
- 26 amend, or repeal a rule resulting from the petition or review
- 27 would increase the regulatory burden placed upon a livestock
- 28 producer.
- 29 b. The request is not accompanied by credible data. In
- 30 order to be credible, data must include facts, measurements,
- 31 or statistics that are collected and analyzed using objective
- 32 methods that are generally scientifically accepted. Data is
- 33 not credible if an agency would not rely upon it alone to
- 34 adopt, amend, or repeal a rule.
- 35 4. This section applies notwithstanding any contrary

- This section does not apply if the agency or
- 3 administrative rules coordinator determines that an action to
- 4 adopt, amend, or repeal a rule resulting from the petition
- 5 or review would substantially decrease the regulatory burden
- 6 placed upon a livestock producer and any increase in the
- 7 regulatory burden placed upon the livestock producer would be
- 8 minimal.
- 9 Sec. 3. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
- 10 immediate importance, takes effect upon enactment.
- 11 EXPLANATION
- 12 REQUESTS FOR AGENCY ACTION. The "Iowa Administrative
- 13 Procedure Act" allows a person to submit a request for agency
- 14 action to adopt, amend, or repeal a rule (Code section 17A.7).
- 15 The request may be in the form of a petition submitted to the
- 16 agency. Generally, the agency must either deny the request
- 17 or initiate rulemaking procedures. A request may also be
- 18 submitted by a person, association, agency, or political
- 19 subdivision to the administrative rules coordinator to order
- 20 the agency to conduct a review and determine whether a rule
- 21 should be amended or repealed or a new rule adopted.
- 22 REQUESTS INVOLVING LIVESTOCK PRODUCTION. This bill provides
- 23 special procedures for a request that would increase the
- 24 regulatory burden placed upon a livestock producer. In that
- 25 case, the agency or administrative rules coordinator must deny
- 26 the request unless it is accompanied by credible data collected
- 27 and analyzed using generally accepted scientific methods. The
- 28 bill provides that the administrative rules coordinator may
- 29 defer the decision to the agency. The bill's provisions do not
- 30 apply even if the agency or administrative rules coordinator
- 31 determines that there would be an increase in the regulatory
- 32 burden, so long as the increase would be minimal and would be
- 33 offset by a substantial decrease in the livestock producer's
- 34 regulatory burden.
