- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 4 The state of Iowa is hereby organized and divided into four
- 5 congressional districts, which shall be composed, respectively,
- 6 of the following counties:
- 7 l. The first district shall consist of the counties of
- 8 Worth, Mitchell, Howard, Winneshiek, Allamakee, Bremer,
- 9 Fayette, Clayton, Black Hawk, Buchanan, Delaware, Dubuque,
- 10 Marshall, Tama, Benton, Linn, Jones, Jackson, Poweshiek, and 11 Iowa.
- 12 2. The second district shall consist of the counties of
- 13 Jasper, Johnson, Cedar, Clinton, Marion, Mahaska, Keokuk,
- 14 Washington, Louisa, Muscatine, Scott, Clarke, Lucas, Monroe,
