

House Study Bill 588 - Introduced

A BILL FOR

1 An Act relating to requirements for the enactment of the state
2 percent of growth and the categorical state percent of
3 growth and including effective date provisions.
4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 257.8, subsections 1 and 2, Code
2 Supplement 2011, are amended to read as follows:

3 1. *State percent of growth.* The state percent of growth
4 for the budget year beginning July 1, 2010, is two percent.
5 The state percent of growth for the budget year beginning
6 July 1, 2012, is two percent. The state percent of growth
7 for ~~each~~ subsequent budget year years shall be established by
8 statute which shall be enacted in each odd-numbered year and
9 shall include the state percent of growth for the budget year
10 beginning July 1 of the calendar year in which the statute is
11 enacted and the state percent of growth for the budget year
12 beginning July 1 of the calendar year following the calendar
13 year in which the statute is enacted. The statute establishing
14 the state percent of growth for both such years shall be
15 enacted within thirty days of the submission ~~in the year~~
16 ~~preceding the base year~~ of the governor's budget under section
17 8.21 in each odd-numbered year. The establishment of the state
18 percent of growth for ~~a budget year~~ both such years pursuant to
19 this subsection shall be the only subject matter of the bill
20 which enacts the state percent of growth ~~for a budget year.~~

21 2. *Categorical state percent of growth.* The categorical
22 state percent of growth for the budget year beginning July
23 1, 2010, is two percent. The categorical state percent of
24 growth for the budget year beginning July 1, 2012, is two
25 percent. The categorical state percent of growth for ~~each~~
26 subsequent budget year years shall be established by statute
27 which shall be enacted in each odd-numbered year and shall
28 include the categorical state percent of growth for the budget
29 year beginning July 1 of the calendar year in which the statute
30 is enacted and the categorical state percent of growth for the
31 budget year beginning July 1 of the calendar year following the
32 calendar year in which the statute is enacted. The statute
33 establishing the state percent of growth for both such years
34 shall be enacted within thirty days of the submission ~~in the~~
35 ~~year preceding the base year~~ of the governor's budget under

1 section 8.21 in each odd-numbered year. The establishment
2 of the categorical state percent of growth for ~~a budget year~~
3 both such years pursuant to this subsection shall be the only
4 subject matter of the bill which enacts the categorical state
5 percent of growth for ~~a budget year~~. The categorical state
6 percent of growth may include state percents of growth for
7 the teacher salary supplement, the professional development
8 supplement, and the early intervention supplement.

9 Sec. 2. EFFECTIVE UPON ENACTMENT. This Act, being deemed of
10 immediate importance, takes effect upon enactment.

EXPLANATION

12 This bill modifies the requirements for enacting the state
13 percent of growth and the categorical state percent of growth
14 under Code section 257.8.

15 Current law requires the state percent of growth and the
16 categorical state percent of growth to be established by
17 statute within 30 days of the submission of the governor's
18 budget in the year preceding the base year.

19 The bill requires the state percent of growth and the
20 categorical state percent of growth to be established by
21 statute in each odd-numbered year for the budget year beginning
22 July 1 of the calendar year in which the statute is enacted
23 and for the budget year beginning July 1 of the calendar year
24 following the calendar year in which the statute is enacted.
25 The bill also requires that the statute establishing such
26 percents of growth be enacted within 30 days of the submission
27 of the governor's budget in each odd-numbered year.

28 The bill takes effect upon enactment.
