A BILL FOR

- 1 An Act concerning the legislative members of the college
- 2 student aid commission and including applicability date
- 3 provisions.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 261.1, subsection 2, paragraph c,
- 2 subparagraphs (1) and (2), Code 2011, are amended to read as
- 3 follows:
- 4 (1) Two members One member of the senate, one to be
- 5 appointed by the president of the senate and one to be
- 6 appointed by after consultation with the majority leader and
- 7 the minority leader of the senate, to serve as an ex officio,
- 8 nonvoting members member.
- 9 (2) Two members One member of the house of representatives,
- 10 one to be appointed by the speaker of the house of
- 11 representatives and one to be appointed by after consultation
- 12 with the majority leader and the minority leader of the house
- 13 of representatives, to serve as an ex officio, nonvoting
- 14 members member.
- 15 Sec. 2. Section 261.1, subsection 2, paragraph c, Code 2011,
- 16 is amended by adding the following new subparagraph:
- 17 NEW SUBPARAGRAPH. (4) The two legislative members of the
- 18 commission shall not be members of the same political party.
- 19 The president of the senate and the speaker of the house of
- 20 representatives shall consult with one another prior to any
- 21 appointment made pursuant to this paragraph "c" to ensure the
- 22 requirement in this subparagraph is met.
- 23 Sec. 3. APPLICABILITY. This Act applies to the appointment
- 24 of legislative members of the college student aid commission
- 25 for the term beginning upon the convening of the Eighty-fifth
- 26 General Assembly.
- 27 EXPLANATION
- 28 Under current law, there are four ex officio, nonvoting
- 29 legislative members of the college student aid commission. Two
- 30 members are from the senate, one appointed by the president
- 31 of the senate and one appointed by the minority leader of the
- 32 senate. Two members are from the house of representatives,
- 33 one appointed by the speaker of the house of representatives
- 34 and one appointed by the minority leader of the house of
- 35 representatives.

S.F. 141

- 1 This bill provides that there shall be two ex officio,
- 2 nonvoting legislative members of the college student aid
- 3 commission. One shall be from the senate, appointed by the
- 4 president of the senate after consultation with the majority
- 5 leader and the minority leader of the senate, and one shall be
- 6 from the house of representatives, appointed by the speaker
- 7 of the house of representatives after consultation with
- 8 the majority leader and the minority leader of the house of
- 9 representatives.
- 10 The bill provides that the two legislative members of the
- 11 commission shall not be members of the same political party.
- 12 The bill directs the president of the senate and the speaker of
- 13 the house of representatives to consult with one another prior
- 14 to any appointment made pursuant to the bill to carry out that
- 15 requirement.
- 16 The bill applies to the appointment of legislative members
- 17 of the college student aid commission for the term beginning
- 18 upon the convening of the Eighty-fifth General Assembly.
