A BILL FOR

- 1 An Act prohibiting school districts and area education agencies
- 2 from making teacher payroll deductions for membership dues
- 3 for employment organizations or labor unions and including
- 4 applicability provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

S.F. 180

- 1 Section 1. Section 20.9, unnumbered paragraph 1, Code 2011,
- 2 is amended to read as follows:
- 3 The public employer and the employee organization shall meet
- 4 at reasonable times, including meetings reasonably in advance
- 5 of the public employer's budget-making process, to negotiate in
- 6 good faith with respect to wages, hours, vacations, insurance,
- 7 holidays, leaves of absence, shift differentials, overtime
- 8 compensation, supplemental pay, seniority, transfer procedures,
- 9 job classifications, health and safety matters, evaluation
- 10 procedures, procedures for staff reduction, in-service training
- 11 and other matters mutually agreed upon. Negotiations shall
- 12 also include terms authorizing dues checkoff for members
- 13 of the employee organization, other than members who are
- 14 teachers licensed under chapter 272 and who are employed by a
- 15 public employer which is a school district or area education
- 16 agency, and grievance procedures for resolving any questions
- 17 arising under the agreement, which shall be embodied in a
- 18 written agreement and signed by the parties. If an agreement
- 19 provides for dues checkoff, a member's dues may be checked
- 20 off only upon the member's written request and the member may
- 21 terminate the dues checkoff at any time by giving thirty days'
- 22 written notice. Such obligation to negotiate in good faith
- 23 does not compel either party to agree to a proposal or make a
- 24 concession.
- 25 Sec. 2. NEW SECTION. 273.16 Payroll deduction for
- 26 membership dues prohibited.
- 27 An area education agency shall not deduct from a teacher's
- 28 wages or salary membership dues for any employment organization
- 29 or labor union.
- 30 Sec. 3. NEW SECTION. 279.68 Payroll deduction for
- 31 membership dues prohibited.
- 32 A school district shall not deduct from a teacher's wages or
- 33 salary membership dues for any employment organization or labor
- 34 union.
- 35 Sec. 4. APPLICABILITY. This Act applies to collective

- 1 bargaining agreements entered into on or after the effective
- 2 date of this Act.
- 3 EXPLANATION
- 4 This bill prohibits a school district or area education
- 5 agency from deducting membership dues for any employment
- 6 organization or labor union from a teacher's wages or salary.
- 7 The bill removes dues checkoffs for teachers licensed under
- 8 Code chapter 272 who are employed by a public employer which is
- 9 a school district or area education agency from the scope of
- 10 negotiations for collective bargaining agreements under Code
- 11 chapter 20.
- 12 The bill applies to collective bargaining agreements entered
- 13 into on or after the effective date of the bill.
