A BILL FOR

- 1 An Act relating to snowmobile registration and permit fees.
- 2 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

S.F. 192

- 1 Section 1. Section 321G.4, subsection 2, Code 2011, is 2 amended to read as follows:
- 3 2. The owner of the snowmobile shall file an application
- 4 for registration with the department through a county recorder
- 5 in the manner established by the commission. The application
- 6 shall be completed by the owner and shall be accompanied by a
- 7 fee of fifteen thirty dollars and a writing fee as provided
- 8 in section 321G.27. A snowmobile shall not be registered by
- 9 the county recorder until the county recorder is presented
- 10 with receipts, bills of sale, or other satisfactory evidence
- 11 that the sales or use tax has been paid for the purchase of
- 12 the snowmobile or that the owner is exempt from paying the
- 13 tax. A snowmobile that has an expired registration certificate
- 14 from another state may be registered in this state upon proper
- 15 application, payment of all applicable registration and writing
- 16 fees, and payment of a penalty of five dollars.
- 17 Sec. 2. Section 321G.4A, subsection 2, Code 2011, is amended
- 18 to read as follows:
- 19 2. A county recorder or a license agent designated by the
- 20 director pursuant to section 483A.11 may issue user permits.
- 21 The fee for a user permit shall be fifteen thirty dollars plus
- 22 an administrative fee established by the commission. A county
- 23 recorder or a license agent shall retain a writing fee from the
- 24 sale of each user permit as provided in section 321G.27.
- Sec. 3. Section 321G.6, subsections 1 and 4, Code 2011, are
- 26 amended to read as follows:
- 27 l. Every snowmobile registration certificate and
- 28 registration decal issued expires at midnight December 31
- 29 unless sooner terminated or discontinued in accordance with
- 30 this chapter or rules of the commission. After the first
- 31 day of September each year, an unregistered snowmobile
- 32 may be registered and a registration may be renewed in one
- 33 transaction. The fee is five dollars for the remainder of the
- 34 current year, in addition to the registration fee of fifteen
- 35 thirty dollars for the subsequent year beginning January 1, and

- 1 a writing fee as provided in section 321G.27.
- A county recorder or a license agent designated by the
- 3 director pursuant to section 483A.11 may issue snowmobile
- 4 registration renewals electronically pursuant to rules adopted
- 5 by the commission. The fee for a registration renewal issued
- 6 using an electronic system is fifteen thirty dollars plus an
- 7 administrative fee established by the commission and a writing
- 8 fee as provided in section 321G.27.
- 9 EXPLANATION
- 10 This bill increases the annual fee for registration of
- 11 a snowmobile from \$15 to \$30. In addition, the fee for a
- 12 nonresident user permit is increased from \$15 to \$30.
- Pursuant to current law, snowmobile registration fees
- 14 and permit fees are deposited in a special snowmobile fund
- 15 and appropriated to the department of natural resources for
- 16 snowmobile programs, with at least 50 percent of the moneys
- 17 available for political subdivisions and incorporated private
- 18 organizations.
- 19 Every snowmobile operated on public land or ice in the state
- 20 is required to be registered annually with the department,
- 21 except snowmobiles owned and used by the United States,
- 22 another state, or a political subdivision of another state
- 23 and snowmobiles used exclusively as farm implements. State
- 24 agencies and political subdivisions of this state are exempt
- 25 from payment of the annual registration fee.
