## A BILL FOR

- 1 An Act transferring the water resources coordinating council
- 2 from the office of the governor to the department of
- 3 agriculture and land stewardship.
- 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 466B.2, subsection 2, Code 2011, is
- 2 amended by striking the subsection.
- 3 Sec. 2. Section 466B.3, subsection 1, Code 2011, is amended
- 4 to read as follows:
- 5 1. Council established. A water resources coordinating
- 6 council is established within the office of the governor
- 7 department of agriculture and land stewardship.
- 8 Sec. 3. Section 466B.3, subsection 4, paragraph c, Code
- 9 2011, is amended by striking the paragraph.
- 10 Sec. 4. Section 466B.3, subsection 4, paragraph 1,
- 11 unnumbered paragraph 1, Code 2011, is amended to read as
- 12 follows:
- 13 The governor secretary, who shall be the chairperson, or
- 14 the governor's secretary's designee. As the chairperson,
- 15 and in order to further the coordination efforts of the
- 16 council, the governor secretary may invite representatives
- 17 from any other public agency, private organization, business,
- 18 citizen group, or nonprofit entity to give public input at
- 19 council meetings, provided the entity has an interest in the
- 20 coordinated management of land resources, soil conservation,
- 21 flood mitigation, or water quality. The governor secretary
- 22 shall also invite and solicit advice from the following:
- 23 Sec. 5. Section 466B.3, subsection 5, paragraph a, Code
- 24 2011, is amended to read as follows:
- 25 a. The council shall be convened by the office of the
- 26 governor secretary of agriculture at least quarterly.
- 27 Sec. 6. Section 466B.3, subsection 6, paragraph c, Code
- 28 2011, is amended to read as follows:
- 29 c. The council shall develop recommendations for policies
- 30 and funding promoting a watershed management approach to
- 31 reduce the adverse impact of future flooding on this state's
- 32 residents, businesses, communities, and soil and water quality.
- 33 Policy and funding recommendations shall be submitted to the
- 34 governor and the general assembly not later than November
- 35 15, 2009. The council shall consider policies and funding

- 1 options for various strategies to reduce the impact of
- 2 flooding including but not limited to additional floodplain
- 3 regulation; wetland protection, restoration, and construction;
- 4 the promulgation and implementation of statewide storm water
- 5 management standards; conservation easements and other land
- 6 management; perennial ground cover and other agricultural
- 7 conservation practices; pervious pavement, bioswales, and
- 8 other urban conservation practices; and permanent or temporary
- 9 water retention structures. In developing recommendations,
- 10 the council shall consult with hydrological and land use
- 11 experts, representatives of cities, counties, drainage and
- 12 levee districts, agricultural interests, and soil and water
- 13 conservation districts, and other urban and regional planning
- 14 experts.
- 15 Sec. 7. Section 466B.5, Code 2011, is amended to read as
- 16 follows:
- 17 466B.5 Regional watershed assessment, planning, and
- 18 prioritization.
- 19 1. Regional watershed assessment program. The department of
- 20 natural resources shall create a regional watershed assessment
- 21 program. The program shall assess all the regional watersheds
- 22 in the state.
- 23 a. The statewide assessment shall be conducted at the rate
- 24 of approximately one-fifth of the watersheds per year, and an
- 25 initial full assessment shall be completed within five years.
- 26 Thereafter, the department of natural resources shall review
- 27 and update the assessments on a regular basis.
- 28 b. Each regional watershed assessment shall provide a
- 29 summary of the overall condition of the watershed. The
- 30 information provided in the summary may include land use
- 31 patterns, soil types, slopes, management practices, stream
- 32 conditions, and both point and nonpoint source impairments.
- 33 c. In conducting a regional watershed assessment, the
- 34 department of natural resources may provide opportunities for
- 35 local data collection and input into the assessment process.

- 1 2. Planning and prioritization. In conducting the regional
- 2 watershed assessment program, the department of natural
- 3 resources shall provide hydrological and geological information
- 4 sufficient for the water resources coordinating council to
- 5 prioritize watersheds statewide and for the various communities
- 6 in those watersheds to plan remedial efforts in their local
- 7 communities and subwatersheds.
- 8 3. Report to council. Upon completion of the statewide
- 9 assessment, and upon updating the assessments, the department
- 10 of natural resources shall report the results of the assessment
- 11 to the council and the general assembly, and shall make the
- 12 report publicly available.
- 13 Sec. 8. Section 466B.6, subsection 1, Code 2011, is amended
- 14 to read as follows:
- 1. Facilitation of community-based subwatershed plans. After
- 16 the department's department of natural resources' completion
- 17 of the initial regional watershed assessment, and after the
- 18 council's prioritization of the regional watersheds, the
- 19 council shall designate one or more of the agencies represented
- 20 on the council to facilitate the development and implementation
- 21 of local, community-based subwatershed improvement plans.
- Sec. 9. Section 466B.7, Code 2011, is amended to read as
- 23 follows:
- 24 466B.7 Community-based subwatershed monitoring.
- 25 1. Monitoring assistance. After completion of the
- 26 statewide regional watershed assessment and prioritization,
- 27 and throughout the implementation of local community-based
- 28 subwatershed improvement plans, the department of natural
- 29 resources shall assist communities with the monitoring and
- 30 measurement of local subwatersheds. The monitoring and
- 31 measurement shall be designed for the particular needs of
- 32 individual communities.
- 33 2. Data collection and use. Local communities in which
- 34 the department of natural resources conducts subwatershed
- 35 monitoring shall use the information to support subwatershed

- 1 planning activities, do local data collection, and identify
- 2 priority areas needing additional resources. Local communities
- 3 shall also collect data over time and use the data to evaluate
- 4 the impacts of their management efforts.
- 5 Sec. 10. Section 466B.8, Code 2011, is amended to read as
- 6 follows:
- 7 466B.8 Wastewater and storm water infrastructure assessment.
- 8 The department of natural resources shall assess and
- 9 prioritize communities within a watershed presenting the
- 10 greatest level of risk to water quality and the health of
- ll residents. This prioritization shall include both sewered and
- 12 unsewered communities.
- 13 Sec. 11. Section 466B.9, Code 2011, is amended to read as
- 14 follows:
- 15 466B.9 Rulemaking authority.
- 16 The department of natural resources and the department
- 17 of agriculture and land stewardship shall have the power and
- 18 authority reasonably necessary to carry out the duties imposed
- 19 by this chapter. As to the department of natural resources,
- 20 this includes rulemaking authority to carry out the regional
- 21 watershed assessment program described in section 466B.5. As
- 22 to the department of agriculture and land stewardship, this
- 23 includes rulemaking authority to assist in the implementation
- 24 of community-based subwatershed improvement plans.
- 25 EXPLANATION
- 26 This bill amends Code chapter 466B which provides for the
- 27 protection of surface water in this state by establishing a
- 28 water resources coordinating council within the office of the
- 29 governor. The council includes members representing a number
- 30 of heads of state agencies as well as the deans of colleges
- 31 of board of regents institutions. The council is responsible
- 32 for coordinating governmental efforts to improve water quality
- 33 in an efficient and fiscally responsible manner. The bill
- 34 also includes programs administered by the department of
- 35 natural resources and the department of agriculture and land

1 stewardship. The bill transfers the council from the office

- 2 of the governor to the secretary of agriculture, and provides
- 3 that the secretary of agriculture and not the governor serves
- 4 as the council's chairperson. A number of provisions in the
- 5 Code chapter refer to the department of natural resources as
- 6 simply "department". The bill includes the full name of the
- 7 department, but does not change its powers or duties.
