A BILL FOR

- 1 An Act relating to the application of certificate of need
- 2 requirements to specialized outpatient surgical facilities,
- 3 providing for fees, and including effective date and
- 4 applicability provisions.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 135.61, subsection 14, Code 2011, is
- 2 amended by adding the following new paragraph:
- 3 NEW PARAGRAPH. g. A specialized outpatient surgical
- 4 facility.
- 5 Sec. 2. Section 135.61, Code 2011, is amended by adding the
- 6 following new subsection:
- 7 NEW SUBSECTION. 21A. "Specialized outpatient surgical
- 8 facility" means a freestanding facility, not including a
- 9 hospital, in which surgical abortion procedures are performed
- 10 after the fetus has attained a postfertilization age of
- 11 twenty weeks or more. For the purposes of this subsection,
- 12 "postfertilization age" means the age of the fetus as calculated
- 13 from fertilization of the human ovum.
- 14 Sec. 3. Section 135.63, subsection 2, paragraph a, Code
- 15 2011, is amended to read as follows:
- 16 a. Private offices and private clinics of an individual
- 17 physician, dentist, or other practitioner or group of
- 18 health care providers, except as provided by section 135.61,
- 19 subsection 18, paragraphs "g'', "h'', and "m'', and subsections 20,
- 20 and 21, and 21A.
- Sec. 4. Section 135.64, subsection 2, Code 2011, is amended
- 22 by adding the following new paragraph:
- 23 NEW PARAGRAPH. e. In the case of a specialized outpatient
- 24 surgical facility, the specialized outpatient surgical facility
- 25 will be located in close proximity to a hospital licensed
- 26 pursuant to chapter 135B that provides the appropriate level of
- 27 perinatal care consistent with 641 IAC 150 for patients of the
- 28 facility in order to preserve the life or health of a pregnant
- 29 woman or fetus.
- 30 Sec. 5. ADMINISTRATIVE RULES. The department of public
- 31 health shall adopt rules to determine the certificate of need
- 32 application fee, in accordance with section 135.63, for a
- 33 specialized outpatient surgical facility as defined in section
- 34 135.61, as amended in this Act.
- 35 Sec. 6. EFFECTIVE DATE. This Act, being deemed of immediate

- 1 importance, takes effect upon enactment.
- 2 Sec. 7. APPLICABILITY. The provisions of this Act shall
- 3 apply to a specialized outpatient surgical facility offered or
- 4 developed in this state on or after the effective date of this
- 5 Act.
- 6 EXPLANATION
- 7 This bill provides that a specialized outpatient surgical
- 8 facility is subject to certificate of need requirements prior
- 9 to being offered or developed in Iowa. The bill defines
- 10 "specialized outpatient surgical facility"; requires that,
- ll in addition to all other criteria that must be met by such a
- 12 facility, a certificate of need may only be granted if the
- 13 facility will be located in close proximity to a hospital
- 14 that provides the appropriate level of perinatal care for its
- 15 patients; and directs the department of public health to adopt
- 16 rules to determine the certificate of need application fee for
- 17 such facilities. The bill takes effect upon enactment and
- 18 is applicable to specialized outpatient surgical facilities
- 19 offered or developed in the state on or after the effective
- 20 date of the bill.
