## A BILL FOR

An Act relating to access to and disclosure of information
 concerning mental health treatment or services involving a
 minor fourteen years of age or older who seeks treatment or
 services due to the minor's thoughts of causing injury to
 self or others.
 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 228.8, subsection 1, unnumbered paragraph 1, Code 2013, is amended to read as follows: <u>A Except as provided in subsection 5, a</u> mental health professional or an employee of or agent for a mental health facility may disclose mental health information to the spouse, parent, adult child, or adult sibling of an individual who has chronic mental illness, if all of the following conditions are met: <u>Sec. 2. Section 228.8, Code 2013, is amended by adding the</u> following new subsection:

11 <u>NEW SUBSECTION</u>. 5. Mental health information relating to a 12 minor fourteen years of age or older who seeks mental health 13 treatment or services due to the minor's thoughts of causing 14 injury to self or others shall not be disclosed to the parent, 15 guardian, or legal custodian of such minor without the minor's 16 consent.

17 Sec. 3. Section 229.2, subsection 1, paragraph a, Code 2013, 18 is amended to read as follows:

*a.* An application for admission to a public or private
hospital for observation, diagnosis, care, and treatment as a
voluntary patient may be made by any person who is mentally
ill or has symptoms of mental illness. <u>A minor fourteen years</u>
of age or older who has had thoughts of causing injury to self
or others may make application under this paragraph "a" and an
<u>application under paragraph</u> "b" shall not be required. The fact
that such minor made such application shall not be reported or
disclosed to the parent, guardian, or legal custodian of such
minor without the minor's consent.

## EXPLANATION

30 Under current law, a mental health professional or an 31 employee or agent for a mental health facility may disclose 32 mental health information to the spouse, parent, adult child, 33 or adult sibling of an individual who has a chronic mental 34 illness under certain circumstances. This bill provides 35 that mental health information relating to a minor who is 14

1 years of age or older who seeks mental health treatment or 2 services due to the minor's thoughts of causing injury to self 3 or others, shall not be disclosed to the parent, guardian, or 4 legal custodian of such minor without the minor's consent. 5 Under current law, a voluntary application for voluntary 6 admission to a public or private hospital for observation, 7 diagnosis, care, and treatment as a voluntary patient may be 8 made by any person who is mentally ill or has symptoms of 9 mental illness; however, in the case of a minor, the parent, 10 guardian, or custodian may make application for admission of ll the minor as a voluntary patient. The bill provides that a 12 minor 14 years of age or older who has had thoughts of causing 13 injury to self or others may make application under the 14 bill and an application by the minor's parent, guardian, or 15 custodian is not required. The fact that such minor made such 16 application shall not be reported or disclosed to the parent, 17 guardian, or legal custodian of such minor without the minor's 18 consent.
