A BILL FOR

- 1 An Act relating to the definition of all-terrain vehicle and
- 2 off-road utility vehicle for purposes of the regulation
- of recreational vehicles by the department of natural
- 4 resources.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 321I.1, subsection 1, paragraph a, Code 2 2013, is amended to read as follows:
- 3 a. "All-terrain vehicle" means a motorized vehicle with
- 4 not less than three and not more than six nonhighway tires
- 5 that is fifty inches or less in width and is limited in engine
- 6 displacement to less than one thousand cubic centimeters or
- 7 less and in total dry weight to less than one thousand two
- 8 hundred pounds and that has a seat or saddle designed to be
- 9 straddled by the operator and handlebars for steering control.
- 10 Sec. 2. Section 321I.1, subsection 17, paragraph a, Code
- 11 2013, is amended to read as follows:
- 12 a. "Off-road utility vehicle" means a motorized vehicle with
- 13 not less than four and not more than eight nonhighway tires or
- 14 rubberized tracks that is sixty-five inches or less in width
- 15 and is limited in engine displacement to less than one thousand
- 16 five hundred cubic centimeters and in total dry weight to not
- 17 more than two thousand pounds and that has a seat that is of
- 18 bucket or bench design, not intended to be straddled by the
- 19 operator, and a steering wheel or control levers for control.
- 20 EXPLANATION
- 21 This bill revises the definitions of "all-terrain vehicle"
- 22 and "off-road utility vehicle" for purposes of Code chapter
- 23 3211, which provides for the registration and regulation of
- 24 all-terrain vehicles and off-road utility vehicles by the
- 25 department of natural resources.
- 26 The definition of "all-terrain vehicle" is amended by adding
- 27 a width limitation of 50 inches or less, by limiting the
- 28 engine displacement to 1,000 cubic centimeters or less, and by
- 29 striking the requirement that the vehicle have a seat or saddle
- 30 designed to be straddled by the operator and handlebars for
- 31 steering control.
- The definition of "off-road utility vehicle" is amended by
- 33 adding a width limitation of 65 inches or less and by striking
- 34 the requirement that the vehicle have a seat of bucket or bench
- 35 design and a steering wheel or control levers.

- The bill does not affect the definitions of "all-terrain
- 2 vehicle" and "off-road utility vehicle" for purposes of Code
- 3 chapter 321, which governs the use of those vehicles on Iowa
- 4 roads.
