- 2 subparagraph (5), unnumbered paragraph 1, Code 2014, is amended
- 3 to read as follows:
- 4 Public buildings, including the site or grounds of, and the
- 5 erection, equipment, remodeling, or reconstruction of, and
- 6 additions or extensions to the buildings, and including the
- 7 provision and maintenance of juvenile detention or shelter care
- 8 facilities, when the cost principal amount of the bonds does
- 9 not exceed the following limits:

- 11 subparagraph (9), Code 2014, is amended to read as follows:
- 12 (9) Public buildings, including the site or grounds of,

- The inclusion of this explanation does not constitute agreement with the explanation's substance by the members of the general assembly.
- 22 This bill relates to county finance by modifying the
- 23 definition of "essential county purpose" to specify that public
- 24 building projects meet the definition of "essential county
- 25 purpose" if the principal amount of the bonds does not exceed
- 26 certain threshold amounts based upon the population of the
- 27 county. Current law specifies that a public building project
- 28 meets the definition of an "essential county purpose" if the
- 29 costs of the project do not exceed certain threshold amounts
- 30 based upon the population of the county.
- 31 The bill also modifies the definition of "general county
- 32 purpose" to specify that public building projects meet the
- 33 definition of "general county purpose" if the principal amount
- 34 of the bonds exceeds certain threshold amounts based upon
- 35 the population of the county. Current law specifies that a

- 1 public building project meets the definition of "general county
- 2 purpose" if the costs of the project exceed certain threshold
- 3 amounts based upon the population of the county.
- 4 Generally, an essential county purpose bond issuance does
- 5 not require approval of the voters and a general county purpose
- 6 bond issuance requires approval of the voters.
