- 1 An Act relating to the continued effect of terms, conditions,
- 2 covenants, and provisions contained in documents and
- 3 instruments creating or regulating multiple housing

- 6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. <u>NEW SECTION</u>. **499A.23 Effect of documents and** 2 instruments.
- 3 1. Unless amended or terminated by this chapter or by the
- 4 following documents or instruments, all terms, conditions,
- 5 covenants, and provisions contained in the following documents
- 6 or instruments shall remain in full force and effect as long as
- 7 the cooperative remains in existence:
- 8 a. The articles of incorporation of the cooperative and any
- 9 amendments thereto.
- 10 b. The bylaws of the cooperative and any amendments thereto.
- 11 c. Any proprietary leases, contracts, or other agreements
- 12 between the cooperative and a member of the cooperative or
- 13 between members of the cooperative.
- 14 d. Any property interests created by any documents or
- 15 instruments specified in paragraph "a", "b", or "c".

- 18 shall not be extinguished, limited, or impaired by application

- 19 Sec. 5. APPLICABILITY. This Act applies to all multiple
- 20 housing cooperatives and horizontal property regimes created
- 21 prior to, and still in existence on, July 1, 2014, and created
- 22 on or after July 1, 2014.

- The inclusion of this explanation does not constitute agreement with
- the explanation's substance by the members of the general assembly.
- 26 This bill relates to the effect of terms, conditions,
- 27 covenants, and provisions contained in documents and
- 28 instruments creating or regulating multiple housing
- 29 cooperatives and horizontal property regimes.
- 30 The bill provides that unless amended or terminated by
- 31 Code chapter 499A (multiple housing cooperatives) or by the
- 32 following documents or instruments, all terms, conditions,
- 33 covenants, and provisions contained in the following documents
- 34 or instruments, and any property interests created by any such
- 35 documents or instruments, shall remain in full force and effect

- 1 as long as the cooperative remains in existence: the articles
- 2 of incorporation and the bylaws of the cooperative and any
- 3 amendments thereto and any proprietary leases, contracts, or
- 4 other agreements between the cooperative and a member of the
- 5 cooperative or between members of the cooperative.
- 6 The bill also provides that unless amended or terminated
- 7 by Code chapter 499B (horizontal property regimes) or by the
- 8 following documents or instruments, all terms, conditions,
- 9 covenants, and provisions contained in the following documents
- 10 or instruments, and any property interests created by any
- 11 such documents or instruments, shall remain in full force
- 12 and effect as long as the cooperative remains in existence:
- 13 the declaration of the horizontal property regime and any
- 14 amendments thereto and the articles of incorporation and the
- 15 bylaws of the horizontal property regime and any amendments
- 16 thereto and any rules and regulations adopted pursuant to the
- 17 declaration or bylaws.
- 18 The bill provides that the rule against perpetuities and
- 19 certain provisions relating to reversion or use restrictions on
- 20 land shall not impair the validity of a document or instrument
- 21 property interest specified in the bill.
- 22 The bill applies to all multiple housing cooperatives and
- 23 horizontal property regimes created prior to, and still in
- 24 existence on, July 1, 2014, and created on or after July 1,
- 25 2014.
