A BILL FOR

- 1 An Act relating to the activities and duties of the state board
- of regents and the board's administrative office.
- 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 262.1, Code 2013, is amended to read as 2 follows:
- 3 262.1 Membership.
- 4 The state board of regents consists of nine members, eight
- 5 seven of whom shall be selected from the state at large solely
- 6 with regard to their qualifications and fitness to discharge
- 7 the duties of the office. The eighth member shall be selected
- 8 by the faculty of the institutions of higher learning governed
- 9 by the board, and the ninth member shall be a student enrolled
- 10 on a full-time basis in good standing at either the graduate
- ll or undergraduate level at one of the institutions listed in
- 12 section 262.7, subsection 1, 2, or 3, at the time of the
- 13 member's appointment. Not more than five members shall be of
- 14 the same political party.
- 15 Sec. 2. Section 262.2, Code 2013, is amended to read as
- 16 follows:
- 17 262.2 Appointment term of office.
- 18 The members, except for the eighth member who is selected as
- 19 specified in section 262.1, shall be appointed by the governor
- 20 subject to confirmation by the senate. Prior to appointing the
- 21 ninth member as specified in section 262.1, the governor shall
- 22 consult with the appropriate student body government at the
- 23 institution at which the proposed appointee is enrolled. The
- 24 term of each member of the board shall be for six years, unless
- 25 the ninth member, appointed in accordance with section 262.1,
- 26 graduates or is no longer enrolled at an institution of higher
- 27 education under the board's control, at which time the term of
- 28 the ninth member shall expire one year from the date on which
- 29 the member graduates or is no longer enrolled in an institution
- 30 of higher education under the board's control. However, if
- 31 within that year the ninth member reenrolls in any institution
- 32 of higher education under the board's control on a full-time
- 33 basis and is a student in good standing at either the graduate
- 34 or undergraduate level, the term of the ninth member shall
- 35 continue in effect. The terms of three members of the board

- 1 shall begin and expire in each odd-numbered year as provided
- 2 in section 69.19.
- 3 Sec. 3. NEW SECTION. 262.3 Board and board office -
- 4 prohibited activities.
- 5 l. A member of the state board of regents, the executive
- 6 director of the board, and professional staff employed for
- 7 the administration of the board's office shall not have any
- 8 business or financial relationship with any person employed by
- 9 an institution governed by the board.
- 10 2. A person who registers as a lobbyist pursuant to section
- 11 68B.36 on behalf of a person who is a member of the state
- 12 board of regents or on behalf of that member's business or
- 13 employer shall not, within two years after the termination of
- 14 such service or employment as a lobbyist, become a lobbyist,
- 15 state relations officer, or governmental liaison for any
- 16 office, program, or department of an institution governed or
- 17 administered by the board.
- 18 Sec. 4. Section 262.6, Code 2013, is amended to read as
- 19 follows:
- 20 262.6 Vacancies.
- 21 Vacancies shall be filled in the same manner in which regular
- 22 appointments are required to be made. If the ninth member
- 23 resigns prior to the expiration of the term, the individual
- 24 appointed to fill the vacancy shall meet the requirements for
- 25 the ninth member specified in section 262.1. Other vacancies
- 26 occurring prior to the expiration of the ninth member's term
- 27 shall be filled in the same manner as the original appointments
- 28 for those vacancies.
- 29 Sec. 5. Section 262.8, Code 2013, is amended to read as
- 30 follows:
- 31 262.8 Meetings public forums public readings.
- 32 1. The board shall meet four times a year. Special meetings
- 33 may be called by the board, by the president of the board, or
- 34 by the executive director of the board upon written request of
- 35 any five members thereof.

- 2. Each regular meeting of the state board of regents
- 2 shall begin with at least thirty minutes for public comment if
- 3 requested by members of the public. A member of the public
- 4 shall be granted up to five minutes to make comments and may be
- 5 granted more time by a member of the board.
- 6 3. At least two members of the state board of regents
- 7 shall hold public forums at which issues relating to the
- 8 activities of the board and the institutions the board governs
- 9 can be discussed and addressed. The forums shall provide
- 10 the community with opportunities to pose questions, receive
- ll answers, and make comments. The board shall divide the state
- 12 into at least four geographic regions, including but not
- 13 limited to northwest, southwest, northeast, and southeast Iowa,
- 14 and shall hold a forum in accordance with this subsection in
- 15 each region at least quarterly. The forums shall be held
- 16 outside the metropolitan areas in which institutions of higher
- 17 learning governed by the state board are located and outside
- 18 of a metropolitan area within the state that has a population
- 19 of two hundred thousand or more. Notice of a forum shall be
- 20 prominently posted on the board's internet site at least two
- 21 weeks prior to the date of the forum.
- 22 4. The board shall hold public readings of a proposal at two
- 23 regular meetings of the board before the board takes action on
- 24 a proposal before the board if the proposal affects an academic
- 25 program at an institution governed by the board, or if the
- 26 estimated cost of the proposal is one hundred thousand dollars
- 27 or more. A quorum of the board must be physically present at
- 28 any board meeting that includes a public reading required by
- 29 this subsection. The affirmative vote of a majority of the
- 30 membership of the board is necessary for any action to be taken
- 31 by the board on a proposal subject to this subsection.
- Sec. 6. Section 262.9C, subsections 2 and 5, Code 2013, are
- 33 amended to read as follows:
- 34 2. The target span of control aggregate ratio of supervisory
- 35 employees to other employees shall be one to fifteen fourteen.

- 1 The target span of control ratio shall not apply to employees
- 2 involved with direct patient care, faculty, and employees in
- 3 other areas of the institutions that must maintain different
- 4 span of control ratios due to federal or state regulations.
- 5. The state board of regents shall present an interim
- 6 report to the governor and general assembly on or before April
- 7 1, 2010, with and annual updates thereafter, detailing the
- 8 effects of the policy on the composition of the workforce, cost
- 9 savings, efficiencies, and outcomes. In addition, the report
- 10 and annual updates shall identify those departments within each
- 11 institution under the control of governed by the board granted
- 12 an exception by the board to the policy as provided in this
- 13 section.
- 14 Sec. 7. Section 262.12, Code 2013, is amended to read as
- 15 follows:
- 16 262.12 Committees and administrative offices under board.
- 17 l. The board of regents shall also have and exercise
- 18 all the powers necessary and convenient for the effective
- 19 administration of its office and of the institutions under
- 20 its control, and to this end may create such committees,
- 21 offices and agencies from its own members or others, and employ
- 22 persons to staff the same, fix their compensation and tenure
- 23 and delegate thereto, or to the administrative officers and
- 24 faculty of the institutions under its control, such part of the
- 25 authority and duties vested by statute in the board, and shall
- 26 formulate and establish such rules, outline such policies and
- 27 prescribe such procedures therefor, all as may be desired or
- 28 determined by the board as recorded in their minutes.
- 29 2. The board of regents shall publish on its internet
- 30 site specific criteria, including qualification requirements
- 31 and preferences, for electing a president of any institution
- 32 of higher learning governed by the board pursuant to section
- 33 262.9, subsection 2.
- 34 EXPLANATION
- 35 This bill relates to activities and duties of the state

- 1 board of regents, the executive director of the board, and
- 2 the professional staff employed for the administration of the
- 3 board's office.
- 4 Currently, the board consists of nine members appointed
- 5 by the governor, eight of whom are selected from the state
- 6 at large, and the ninth is a student enrolled at a regents
- 7 university. The bill provides that the eighth member shall be
- 8 selected by the faculty of the regents universities.
- 9 The bill prohibits a member of the board, the board's
- 10 executive director, and the board's professional staff from
- 11 having any business or financial relationship with any person
- 12 employed by a regents institution.
- 13 A person who registers as a lobbyist on behalf of a person
- 14 who is a member of the board or on behalf of that member's
- 15 business or employer shall not within two years after the
- 16 termination of such service or employment as a lobbyist become
- 17 a lobbyist, state relations officer, or governmental liaison
- 18 for any office, program, or department of an institution
- 19 governed or administered by the board.
- 20 Each regular board meeting shall begin with at least 30
- 21 minutes for public comment if requested by members of the
- 22 public. A member of the public shall be granted up to five
- 23 minutes to make comments and may be granted more time by a
- 24 member of the board.
- 25 At least two members of the board shall hold public forums
- 26 in each of at least four geographic regions of the state
- 27 quarterly. The forums must be held outside of the metropolitan
- 28 areas in which the regents universities are located, and
- 29 outside of Des Moines. Notice of a forum must be prominently
- 30 posted on the board's internet site at least two weeks prior to
- 31 the date of the forum.
- 32 If a proposal before the board affects an institution's
- 33 academic program or if its estimated cost is \$100,000 or
- 34 more, the bill requires that the board hold public readings
- 35 of the proposal at two regular meetings of the board before

- 1 taking action on the proposal. A quorum of the board must be
- 2 physically present at these meetings, and the proposal must
- 3 receive the affirmative vote of a majority of the membership
- 4 for any action to be taken on the proposal.
- 5 The bill reduces the target span of control aggregate ratio
- 6 of supervisory employees to other employees at the institutions
- 7 governed by the board from 1 to 15 to 1 to 14.
- 8 The board must publish on its internet site specific
- 9 criteria for electing a president of a regents university.
- 10 The bill includes conforming changes.
