## A BILL FOR

- 1 An Act relating to elections administration with respect to the
- 2 address confidentiality program, the printing of ballots,
- 3 satellite absentee voting, and the conduct of school
- 4 district elections.
- 5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 9E.6, subsection 1, Code 2016, is amended
- 2 to read as follows:
- 3 1. a. A program participant who is an eligible elector
- 4 may register to vote with the state commissioner of elections,
- 5 pursuant to section 48A.8, subsection 1. The name, address,
- 6 and telephone number of a program participant shall not be
- 7 listed in the statewide voter registration system.
- 8 b. A program participant's voter registration shall not be
- 9 open to challenge under section 48A.14 based on participation
- 10 in the program and use of a designated address.
- 11 Sec. 2. Section 9E.6, Code 2016, is amended by adding the
- 12 following new subsection:
- NEW SUBSECTION. 3. a. An absentee ballot submitted by a
- 14 program participant shall not be subject to a challenge under
- 15 section 49.79 or 53.31 if the challenge is based on the voter's
- 16 participation in the program and use of a designated address.
- 17 b. In an election contested pursuant to chapter 57:
- 18 (1) The state commissioner of elections shall, upon
- 19 the written request of a party to the contest, certify the
- 20 eligibility of a program participant to vote or the validity
- 21 of a program participant's absentee ballot. A written request
- 22 submitted under this paragraph "b" must contain the voter
- 23 identification number affixed to the program participant's
- 24 absentee ballot.
- 25 (2) A deposition shall serve as testimony for a program
- 26 participant. A court or tribunal trying the contest shall
- 27 coordinate with the secretary to obtain a deposition from a
- 28 program participant.
- 29 Sec. 3. Section 43.27, Code 2016, is amended to read as
- 30 follows:
- 31 43.27 Printing of ballots.
- 32 The text printed on ballots of each political party shall
- 33 be printed in black ink, on separate sheets of paper, uniform
- 34 in quality, texture, and size, with the name of the political
- 35 party printed at the head of said the ballots, which ballots

- 1 shall be prepared by the commissioner in the same manner as for
- 2 the general election, except as in this chapter provided. The
- 3 commissioner may print the ballots for each political party
- 4 using a different color for each party. If colored paper is
- 5 used, all of the ballots for each separate party shall be
- 6 uniform in color.
- 7 Sec. 4. Section 52.28, Code 2016, is amended to read as
- 8 follows:
- 9 52.28 Optical scan voting system ballot forms.
- 10 The commissioner of each county in which the use of an
- 11 optical scan voting system in one or more precincts has been
- 12 authorized shall print text on optical scan ballots using
- 13 black ink on white paper and shall determine the arrangement
- 14 of candidates' names and public questions upon the ballot or
- 15 ballots used with the system. The ballot information shall
- 16 be arranged as required by chapters 43 and 49, and by any
- 17 relevant provisions of any statutes which specify the form of
- 18 ballots for special elections, so far as possible within the
- 19 constraints of the physical characteristics of the optical scan
- 20 voting system in use in that county. The state commissioner
- 21 may adopt rules requiring a reasonable degree of uniformity
- 22 among counties in arrangement of optical scan voting system
- 23 ballots.
- Sec. 5. Section 53.10, subsection 3, Code 2016, is amended
- 25 to read as follows:
- 26 3. During the hours when absentee ballots are available in
- 27 the office of the commissioner, electioneering shall not be
- 28 allowed within the sight or hearing of voters at the absentee
- 29 voting site is a polling place for purposes of section 39A.4,
- 30 subsection 1, paragraph "a".
- 31 Sec. 6. Section 53.11, subsection 4, Code 2016, is amended
- 32 to read as follows:
- 33 4. During the hours when absentee ballots are available at a
- 34 satellite absentee voting station, electioneering shall not be
- 35 allowed within the sight or hearing of voters at the satellite

- 1 absentee voting station is a polling place for purposes of
- 2 section 39A.4, subsection 1, paragraph "a".
- 3 Sec. 7. Section 275.1, subsection 1, paragraphs b and f,
- 4 Code 2016, are amended to read as follows:
- 5 b. "Initial board" means the board of a newly reorganized
- 6 district that is selected pursuant to section 275.25 or 275.41
- 7 and functions until the organizational meeting following the
- 8 third second regular school election held after the effective
- 9 date of the reorganization.
- 10 f. "Regular board" means the board of a reorganized district
- 11 that begins to function at the organizational meeting following
- 12 the third second regular school election held after the
- 13 effective date of the school reorganization, and is comprised
- 14 of members who were elected to the current terms or were
- 15 appointed to replace members who were elected.
- 16 Sec. 8. Section 275.41, subsection 3, Code 2016, is amended
- 17 to read as follows:
- 3. Prior to the effective date of the reorganization,
- 19 the initial board shall approve a plan that commences at the
- 20 first regular school election held after the effective date
- 21 of the merger and is completed at the third second regular
- 22 school election held after the effective date of the merger,
- 23 to replace the initial board with the regular board. If the
- 24 petition specifies a number of directors on the regular board
- 25 to be different from the number of directors on the initial
- 26 board, the plan shall provide that the number specified in
- 27 the petition for the regular board is in place by the time
- 28 the regular board is formed. The plan shall provide that as
- 29 nearly as possible one-half of the members of the board shall
- 30 be elected biennially, and if a special election was held to
- 31 elect a member to create an odd number of members on the board,
- 32 the term of that member shall end at the organizational meeting
- 33 following the third second regular school election held after
- 34 the effective date.
- 35 Sec. 9. Section 279.6, subsection 1, paragraph a, Code 2016,

1 is amended to read as follows:

- 2 a. Except as provided in paragraph "b" and subsection
- 3 2, vacancies occurring among the officers or members of a
- 4 school board shall be filled by the board by appointment. A
- 5 person so appointed to fill a vacancy in an elective office
- 6 shall hold office until a successor is elected and qualified
- 7 pursuant to at the next regular school election, unless there
- 8 is an intervening special election for the school district, in
- 9 which event a successor shall be elected at the intervening
- 10 special election, in accordance with section 69.12. To fill
- 11 a vacancy occurring among the members of a school board, the
- 12 board shall publish notice in the manner prescribed by section
- 13 279.36, stating that the board intends to fill the vacancy
- 14 by appointment but that the electors of the school district
- 15 have the right to file a petition requiring that the vacancy
- 16 be filled by a special election conducted pursuant to section
- 17 279.7. The board may publish notice in advance if a member
- 18 of the board submits a resignation to take effect at a future
- .9 date. The board may make an appointment to fill the vacancy
- 20 after the notice is published or after the vacancy occurs,
- 21 whichever is later.
- 22 Sec. 10. Section 279.7, subsection 1, Code 2016, is amended
- 23 to read as follows:
- 24 l. If a vacancy or vacancies occur among the elective
- 25 officers or members of a school board and the remaining members
- 26 of the board have not filled the vacancy within thirty days
- 27 after the vacancy becomes known by the secretary or the board
- 28 occurs or if a valid petition is submitted to the secretary
- 29 of the board pursuant to section 279.6, subsection 1, or
- 30 when the board is reduced below a quorum, the secretary of
- 31 the board, or if there is no secretary, the area education
- 32 agency administrator, shall call a special election in the
- 33 district, subdistrict, or subdistricts, as the case may be,
- 34 to fill the vacancy or vacancies. The county commissioner of
- 35 elections shall publish the notices required by law for special

1 elections, and the election shall be held not sooner than
 2 thirty days nor later than forty days after the thirtieth day
 3 following the day the vacancy becomes known by the secretary or
 4 the board occurs.
                      If the secretary fails for more than three
 5 days to call an election, the administrator shall call it.

      This bill relates to elections administration with respect
10 to the address confidentiality program administered by the
ll secretary of state, to the printing of ballots, to satellite
12 absentee voting, and to the conduct of school district
13 elections.
      Relating to the state's address confidentiality program, the
14

- 15 bill provides that a program participant's voter registration
  16 is not subject to challenge based on participation in the
  17 program and the use of a designated address nor is it allowed
  18 to be the basis for challenges under Code sections 49.79
  19 (election day voting) or 53.31 (absentee voting). In the case
  20 of an election contest, the bill provides for the certification
  21 of a program participant's eligibility to vote and the validity
  22 of a program participant's absentee ballot. The bill also
  23 provides that the deposition of a program participant shall
  24 serve as testimony in a contested election.
- 25 Relating to the printing of ballots, the bill specifies that 26 text printed on ballots be in black ink.
- Relating to satellite absentee voting, current law prohibits electioneering within the sight or hearing of voters at the satellite absentee voting station. Under current Code section 30 39A.4, subsection 1, electioneering and other specified activity is prohibited on the premises of a polling place or within 300 feet of an outside door of a building affording access to a room where the polls are held, or of an outside door of a building affording,

- 1 are held. The bill provides that a satellite absentee voting
- 2 station and an absentee voting site at a county commissioner of
- 3 elections office are also polling places for purposes of Code
- 4 section 39A.4, subsection 1.
- 5 Relating to school district elections, the bill requires
- 6 that a plan for school district reorganization be completed
- 7 at the second regular school election following the effective
- 8 date of the reorganization. Current law provides that
- 9 reorganization plans be commenced at the first regular school
- 10 election and be completed at the third regular school election.
- Also relating to school elections, the bill provides that
- 12 when a school board vacancy occurs, that a person appointed to
- 13 fill the vacancy shall hold office until a successor is elected
- 14 and qualified at the next regular school election unless there
- 15 is an intervening special election. The bill also makes
- 16 terminology changes related to the timing required for calling
- 17 and holding a special election when a school board vacancy
- 18 occurs and a replacement has not been appointed.
